ASSIGNMENT and ASSUMPTION in connection with RESTRICTIVE COVENANTS

This Assignment and Assumption is made by and among South Industrial Park LLC, a Nebraska limited liability company, Assurity Life Insurance Co., f/k/a Security Financial Life Insurance Co., a Nebraska corporation, a Nebraska limited liability company (the "Owners", as defined in the Covenants), and Horizon Business Center Association, Inc., a Nebraska nonprofit corporation (the "Association"), with respect to the real estate known as Horizon Business Center legally described on the Exhibit "A" attached hereto (the "Property") and in connection with Restrictive Covenants filed with the Lancaster County Register of Deeds September 5, 2000 as Inst. No. 2000-038888, amended by Inst. No. 2001-032738, Inst. No. 2014039554, and Inst. No. 2014048264 (collectively, the "Covenants").

Background. Article 6 of the Covenants permits the transfer of Owners' architectural control rights to the Association at any time, but requires that the rights and duties of the Owners be assigned to the Association after buildings have been placed or constructed upon three-fourths of the Lots within the Property. As of this date, buildings have been constructed on 15 of the 22 Lots within the Property. The Owners desire to quitclaim and assign to the Association all of the Owners' rights and duties as Owner under Article 6, Architectural Control, reserving unto Owners such rights only for the two Lots of which the Owners are titleholders, as shown on Exhibit "A". Association desires to accept and assume such rights and duties at this time.

NOW THEREFORE, in consideration of the foregoing background, **South Industrial Park LLC** and **Assurity Life Insurance Co.** hereby quitclaim and assign all of their rights and duties as "Owner" under Article 6 of the Covenants pertaining to Architectural Control, reserving unto Owners such rights only for the two Lots of which the Owners are titleholders as shown on Exhibit "A", to **Horizon Business Center Association**, **Inc.** The Association hereby assumes from the Owners, the foregoing rights and duties.

This Assignment and Assumption shall become effective on the date it is filed with the Lancaster County, Nebraska Register of Deeds.
