FOR AND IN CONSIDERATION of the sum of ONE DOLLAR and other valuable consideration, the receipt whereof is hereby acknowledged, ANTILLES CORPORATION, a Nebraska corporation, on behalf of itself, its heirs and assigns, does hereby grant, sell and convey unto SANITARY AND IMPROVEMENT DISTRICT NO. 51 OF SARPY COUNTY, NEBRASKA, its successors, assigns and lessees, forever and in perpetuity from the date hereof, the right to use the lands hereinafter described as a Water Well. The easement and license herein conveyed shall be on that piece of real estate situated in Sarpy County and the state of Nebraska, more particularly described in Exhibit "A" attached hereto and made a part hereof.

IT IS UNDERSTOOD that Sanitary and Improvement District No. 51 of Sarpy County, Nebraska, its successors and assigns, forever, may construct, maintain, deepen and keep in repair a Water Well system above, on and under the said real estate.

IT IS FURTHER UNDERSTOOD that Sanitary and Improvement District No. 51 of Sarpy County, Nebraska, its employees, agents, assigns and lessees, at all times have free access to and egress from and over the said real estate to maintain and keep in repair the well system located thereon.



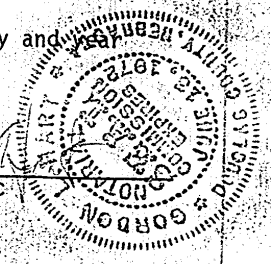

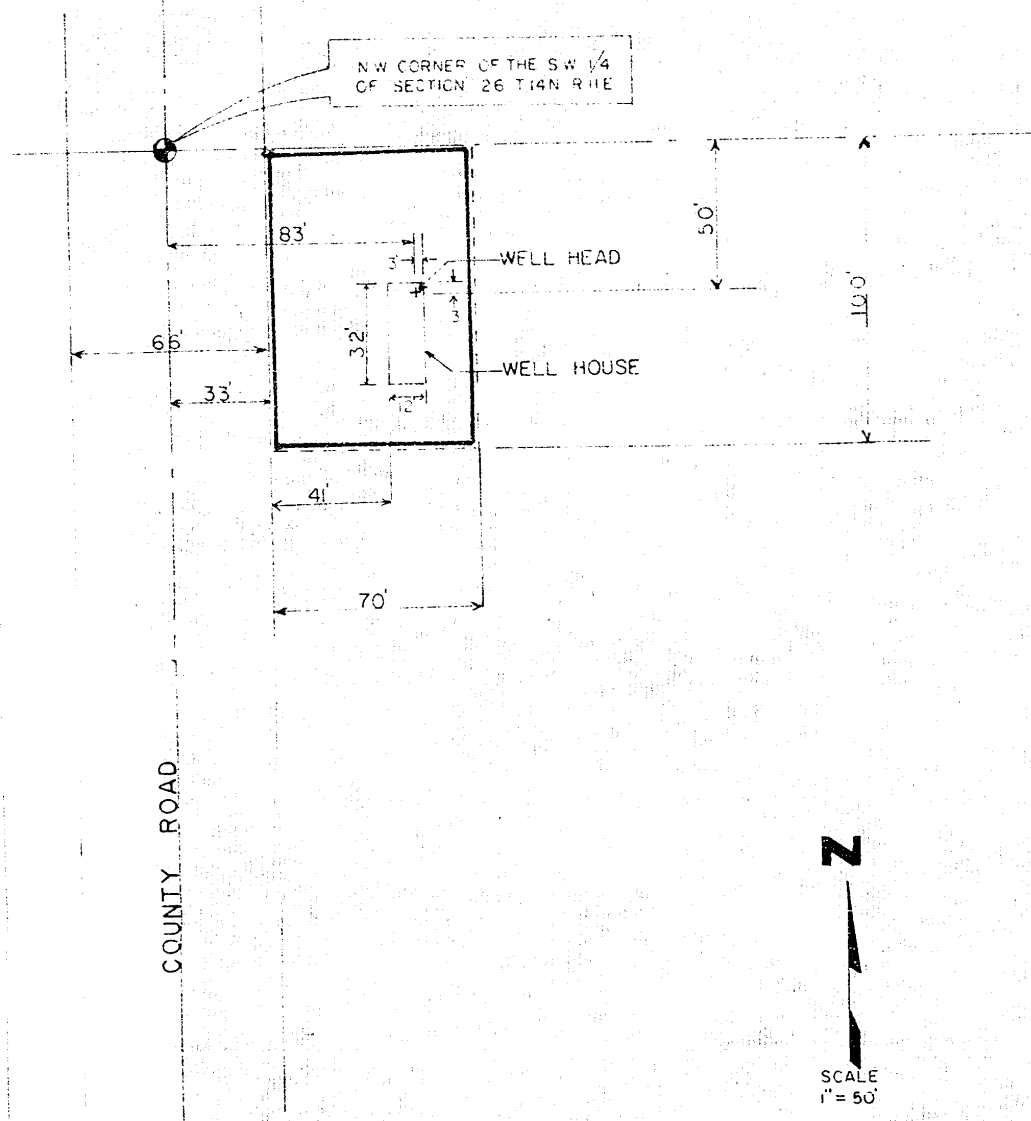
