


## 1ST ADDITION

SURVEYORS CERTIFICATE

I hereby certify that I have accurately staked the lots of the 1st Addition to Irvington, Douglas County, Nebraska as shown on this plat, and driven an iron pipe at all lot corners.

I further certify that the correct description of the land occupied by said addition is as follows:

That part of the N.E.  $\frac{1}{4}$  of the N.W.  $\frac{1}{4}$  of Section 34, T. 16N., R. 12 E. of the 6th P.M. Douglas County Nebraska described and bounded as follows:

Commencing at the northwest corner of said Section 34 and running thence east on the north line of said Section 34, 1979 feet to the center line of Douglas county road 47-B; thence S. 18° 20' E. on the center line of said road 47-B, 925.2 feet; thence N. 71° 20' E., 33 feet to the easterly line of said road; the point of beginning of this description; thence S. 18° 20' E. on the easterly line of said road 47-B, 487 feet; thence S. 85° 44' E., 121 feet; thence N. 32° 31' W. 48.4 feet; thence N. 18° 20' W. 335.3 feet; thence N. 27° 04' W. 54.2 feet; thence N. 0° 57' W. 65 feet; thence west 115 feet to the point of beginning.


