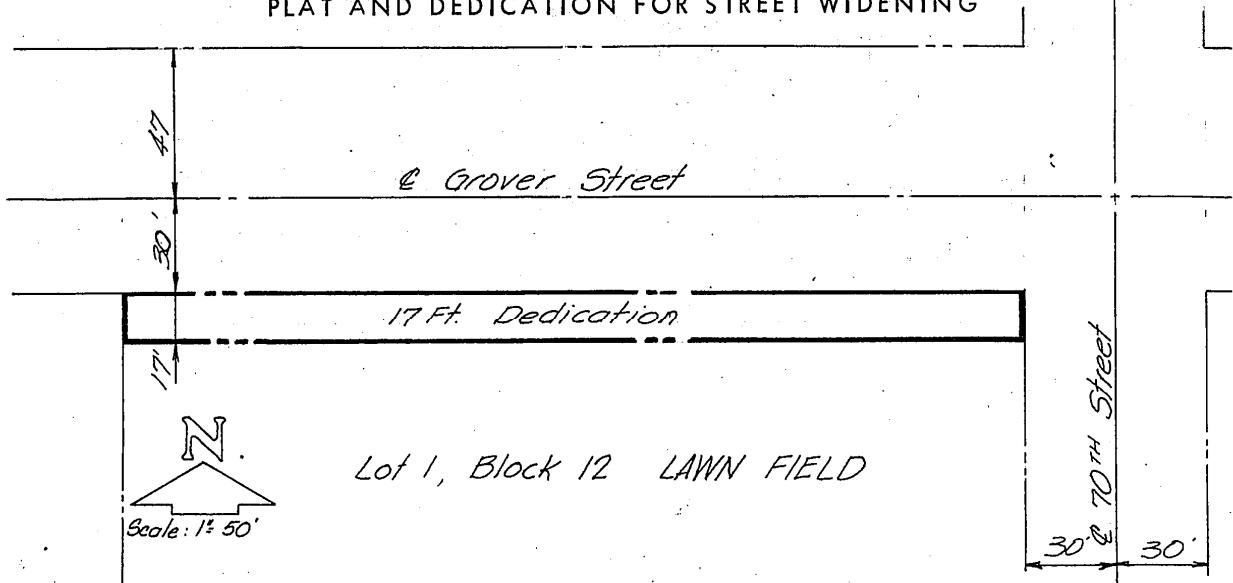


PLAT AND DEDICATION FOR STREET WIDENING

LEGAL DESCRIPTION:

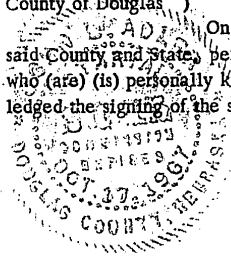
