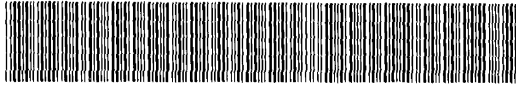

SPECIAL WARRANTY DEED


GRANTOR covenants with GRANTEE that GRANTOR:

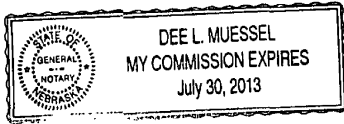

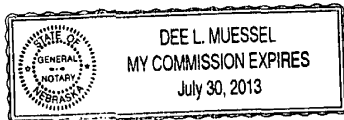
