KNOW ALL MEN BY THESE PRESENTS:



Hossack, State Engineer, in the name of the State of Nebraska, and for the Department of Roads of the State of Nebraska, under the provisions of Section 39-1326, Revised Statutes of Nebraska, 1943, for and in consideration of the sum of - - - One and 00/100 - - - (\$1.00) - - - DOLLARS, do remise, release and forever quit claim unto Omaha Industrial Foundation, A CORPORATION, its successors and assigns the following described real estate situated in Douglas County, and State of Nebraska, to-wit:


That portion of the controlled access line located in the Northwest Quarter of Section 4, Township 14 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Referring to the west quarter corner of said Section 4; thence northerly on the West line of the Northwest Quarter of said Section 4 a distance of 300.0 feet; thence easterly 90 degrees 00 minutes right a distance of 33.0 feet to the point of beginning of said controlled access line; thence northerly on a line 33.0 feet easterly from and parallel to said West line and on said controlled access line a distance of 200.0 feet to the point of termination of said controlled access line.

TO HAVE AND TO HOLD unto the said Omaha Industrial Foundation, A CORPORATION, its successors and assigns forever.
