PARTIAL RELEASE AND AMENDMENT TO PROTECTIVE COVENANTS AND EASEMENTS

All of the other provisions of said Protective Covenants and Easements shall remain in full force and effect as to all of the lots covered thereby, and all of the said provisions of said Protective Covenants and Easements shall remain in full force and effect as to Lots One (1), Two (2), Four (4), and Five (5), Block Five (5), Rockbrook Heights except as herein stated, amended, and released.
