THIS AGREEMENT Made this 21st day of December, 1915, between James P. Martin, of Sicux City, lowe, party of the first part, and The Pelletier Building Company, a corporation of Sicux City, Iowa, party of the second part,

WITNESSETH: That the said parties, being the owners of adjoining estate, the said James P. Martin being the owner of the North half of Lot Eleven(11), in Block Bixteen (16), Sioux City East Addition, an addition to Sioux City, Iowa, and The Pelletier Building Company being the owner of the South half of said lot Eleven (11), in Block Sixteen (16), Sioux City East Addition, an addition to Sioux City, Iowa, the boundary line between said estates being on a line in the center of the said lot eleven (11) extending east and west through said lot, and the said adjoining owners having heretofore each contributed one-half of the expense of building the wall up to sixth-eight(63) feet, nine(9) inches from the street level of said buildings, and the walls above that heighth being the exclusive wall of the said first party for One Hundred (100) feet West from Pierce Street, and the balance of the wall extending to the alley being the exclusive property of The Pelletier Building Company.

IT IS NOW, THEREFORE, HEREBY MUTUALLY AGREED AND COVENANTED for himself and his heirs, successors and heirs, successors and assigns to and with the other and his heirs, successors and assigns that the wall extending east and west through the menter of said lot Eleven assigns that the wall extending saxty-eight feet and nine inches from the street level for (11) up to and including sixty-eight feet and nine inches from the street level for One Hundred feet West from Pierce Street, is located on the boundary line between the size idestates and that each party hereto has heretofore contributed one-half of the expense of building the said wall up to and including the sixty-eight feet and nine inches from the street level thereof, which is the top of the present building of The Pelletier Building Company and that the said wall is a wall in common between them for one hundred feet West from Pierce Street and that the balance of said wall being fifty feet and extending to the North and South alley through said block sixteen belongs and is the exclusive property of The Pelletier Building Company.

IT IS NOW, THEREFORE, HEREBY MUTUALLY ACREED AND COVENANTED for himself and his heirs, successors and heirs, successors and assigns to and with the other and his heirs, successors and assigns that the wall extending east and west through the menter of said lot Eleven (11) up to and including sixty-eight feet and nine inches from the street level for One Hundred feet West from Pierce Street, is located on the boundary line between the size ideatass and that each party hereto has heretofore contributed one-half of the expense of building the said wall up to and including the sixty-eight feet and nine inches from the street level thereof, which is the top of the present building nine inches from the street level thereof, which is the top of the present building of the Pelletier Building Company and that the said wall is a wall in common between them for one hundred feet West from Pierce Street and that the balance of said wall being fifty feet and extending to the North and South alley through said block sixteen belongs and is the exclusive property of the Pelletier Building Company.

IT IS TURTHER HEREBY EXPRESSLY AGREED that that portion of the wall west of the east one hundred(100) feet was built by and is owned by The Pelletier Building Company, and that all of that portion of said wall extending east and west through the center of said lot eleven (11) above sixty-eight feet and nine inches from the street level for One Hundred feet west from Pierce Street was built by and is owned by James P. Martin.
