01 AN ORDINANCE vacating various street and alley portions located
02 generally between 7th and 8th Streets, and north of "T" Street, and retaining
03 title thereto in the City of Lincoln, Lancaster County, Nebraska.

04 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

05 Section 1. That 8th Street from the centerline of "T" Street
06 north to the westerly extension of the north line of Lot 4, Block 14, North
07 Lincoln Addition, be and the same is hereby vacated, subject to the title of
08 said street being vacated remaining in the City of Lincoln, Lancaster County,
09 Nebraska.

10 Section 2. That the public right-of-way (unnamed) north of Block
11 7, and south of Block 13, Original Plat from the east line of 7th Street to
12 the west line of 8th Street, be and the same is hereby vacated, subject to the
13 title of said right-of-way being vacated remaining in the City of Lincoln,
14 Lancaster County, Nebraska.

15 Section 3. That "U" Street from the east right-of-way line of
16 7th Street to the west right-of-way line of 8th Street, be and the same is
17 hereby vacated, subject to the title of said street being vacated remaining in
18 the City of Lincoln, Lancaster County, Nebraska.

19 Section 4. That the north-south alley in Block 7, Original Plat,
20 Lincoln, Lancaster County, Nebraska, be and the same is hereby vacated,
21 subject to the title of said alley being vacated remaining in the City of
22 Lincoln, Lancaster County, Nebraska.


23 Section 5. That all of the north/south alley and the east/west
24 alley in Block 8, Original Plat, be and the same is hereby vacated subject to
25 the title of said alleys being vacated remaining in the City of Lincoln,


Section 6. That this ordinance shall take effect and be in force from and after its passage and publication according to law.



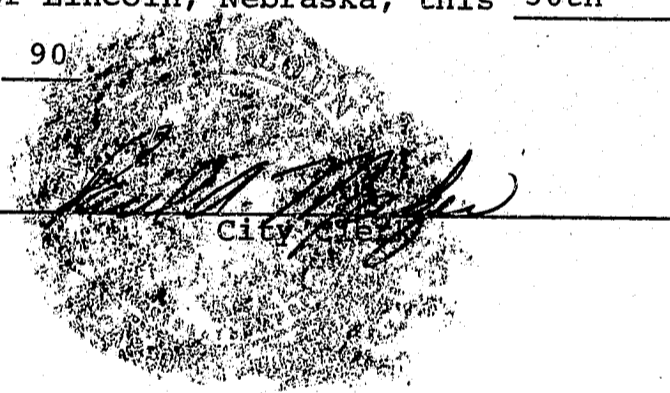
