Lot Three (3) in Block Twenty-three (23), in South Papillion, an Addition to the City of Papillion, Sarpy County, Nebraska

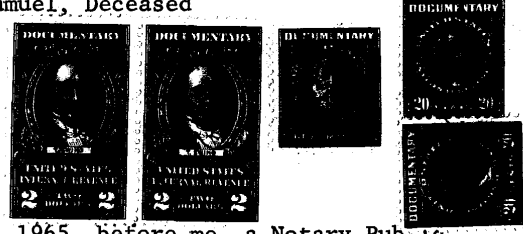

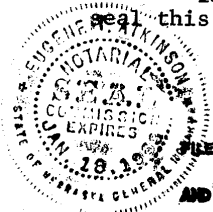
