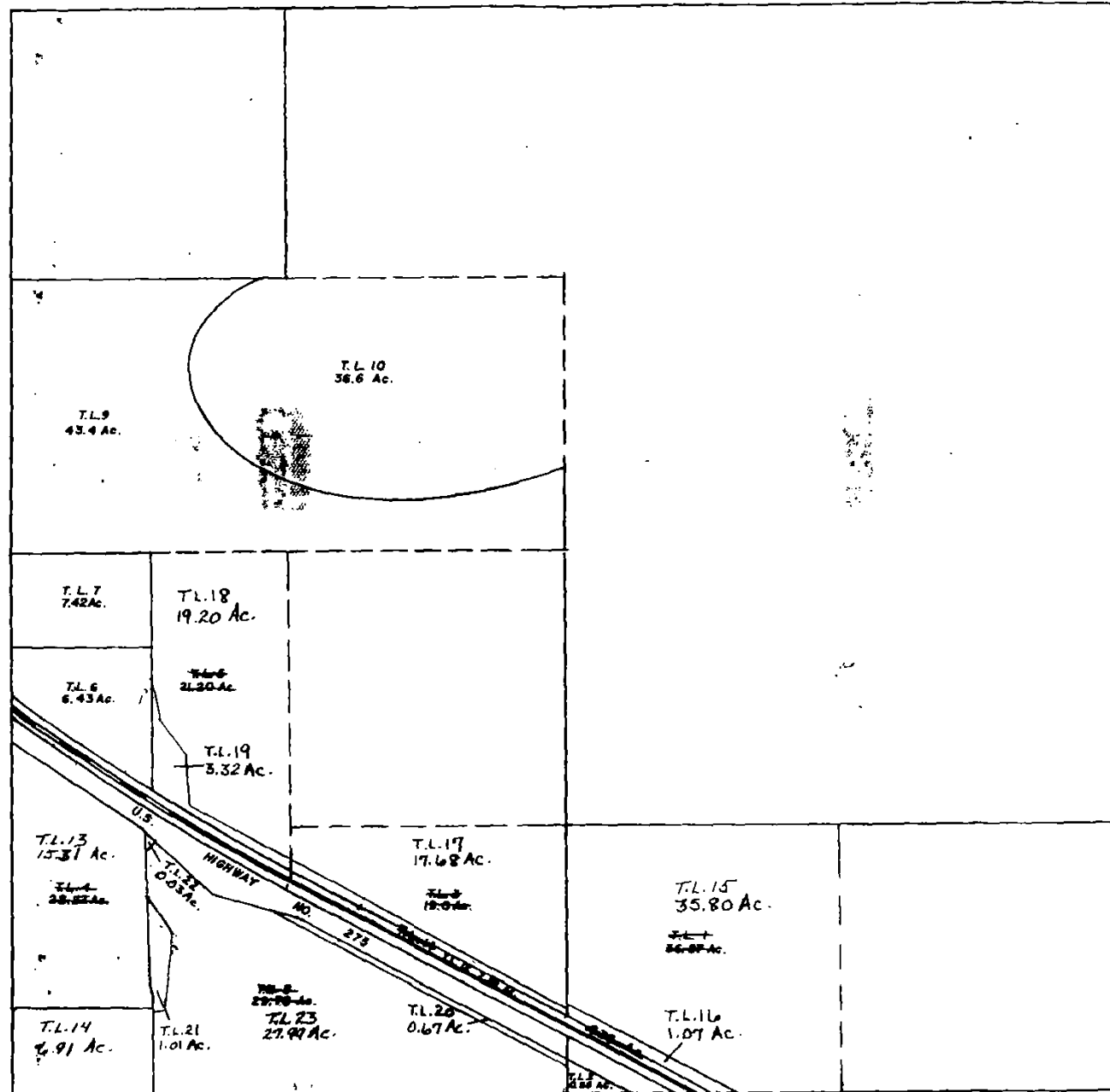

TAX LOT 9 (1975)

THE S $\frac{1}{2}$ NW $\frac{1}{4}$ OF SECTION 10, T 19 N, R 7 E OF THE 6TH. P.M., DODGE COUNTY, NEBRASKA, LYING SOUTH AND WEST OF THE OLD RIVER BED, CONTAINING 43.4 ACRES, MORE OR LESS.

TAX LOT 10 (1975)

THE S $\frac{1}{2}$ NW $\frac{1}{4}$ OF SECTION 10, T 19 N, R 7 E OF THE 6TH. P.M., DODGE COUNTY, NEBRASKA, LYING NORTH AND EAST OF THE OLD RIVER BED, CONTAINING 36.6 ACRES, MORE OR LESS.

TAX LOT 11 (1988)

A TRACT OF LAND CONSISTING OF: 2.41 ACRES IN THE NW $\frac{1}{4}$ SW $\frac{1}{4}$; 1.29 ACRES IN THE SW $\frac{1}{4}$ SW $\frac{1}{4}$; 3.44 ACRES IN THE SE $\frac{1}{4}$ SW $\frac{1}{4}$; AND 1.61 ACRES IN THE SW $\frac{1}{4}$ SE $\frac{1}{4}$; FOR A TOTAL OF 8.75 ACRES, MORE OR LESS; ALL IN SECTION 10, T19N, R7E OF THE 6TH P.M., DODGE COUNTY, NEBRASKA, BEING THE C. & N.W. A TRACT OF LAND CONSISTING OF 1.72 ACRES IN THE SE $\frac{1}{4}$ SW $\frac{1}{4}$; AND 0.86 ACRES IN THE SW $\frac{1}{4}$ SE $\frac{1}{4}$; FOR A TOTAL OF 2.59 ACRES, MORE OR LESS; ALL IN SECTION 10, TOWNSHIP 19 NORTH, RANGE 7 EAST OF THE 6TH P.M., DODGE COUNTY, NEBRASKA, LYING NORTHEASTERLY OF THE CENTERLINE OF THE MAIN LINE TRACK OF THE OLD C&NW RAILROAD.

TAX LOT 13 (FORMERLY TAX LOT 4) (2003)

A TRACT OF LAND LOCATED IN THE W $\frac{1}{4}$ SW $\frac{1}{4}$ OF SECTION 10, TOWNSHIP 19 NORTH, RANGE 7 EAST OF THE 6TH P.M., DODGE COUNTY, NEBRASKA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE INTERSECTION OF THE WEST LINE OF SAID SECTION 10 AND THE SOUTHWESTERLY ROW OF HWY 275; THENCE SOUTH ALONG SAID WEST SECTION LINE AN APPROXIMATE DISTANCE OF 1365.90'; THENCE EAST AN APPROXIMATE DISTANCE OF 640.00' TO A POINT 30.00' WEST OF THE WEST PROPERTY LINE OF THE SCRIBNER AIR FORCE BASE ACCESS ROAD; THENCE NORTH AN APPROXIMATE DISTANCE OF 60.00' TO INTERSECT SAID WEST PROPERTY LINE; THENCE N 14°30' W A DISTANCE OF 18.00'; THENCE WEST ALONG THE PROPERTY LINE OF SAID ACCESS ROAD A DISTANCE OF 44.50'; THENCE NORTH ALONG THE WEST PROPERTY LINE OF THE SCRIBNER AIR FORCE BASE A DISTANCE OF 856.00' TO A POINT ON THE SOUTHWESTERLY ROW OF HWY 275; THENCE NORTHWESTERLY ALONG SAID ROW TO THE POINT OF BEGINNING, AND CONTAINING 15.31 ACRES, MORE OR LESS.

TAX LOT 14 (FORMERLY TAX LOT 4) (2003)

A TRACT OF LAND LOCATED IN THE SW $\frac{1}{4}$ SW $\frac{1}{4}$ OF SECTION 10, TOWNSHIP 19 NORTH, RANGE 7 EAST OF THE 6TH P.M., DODGE COUNTY, NEBRASKA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE INTERSECTION OF THE WEST LINE OF SAID SECTION 10 AND THE SOUTHWESTERLY ROW OF HWY 275; THENCE SOUTH ALONG SAID WEST SECTION LINE AN APPROXIMATE DISTANCE OF 1365.90' TO THE POINT OF BEGINNING; THENCE CONTINUING SOUTH ALONG SAID WEST SECTION LINE AN APPROXIMATE DISTANCE OF 440.00'; THENCE EAST ALONG THE SOUTH SECTION LINE A DISTANCE OF 660.00' TO A POINT 30.00' WEST OF THE WEST PROPERTY LINE OF THE SCRIBNER AIR FORCE BASE ACCESS ROAD; THENCE NORTH AN APPROXIMATE CHORD DISTANCE OF 440.45', RADIUS BEARING APPROXIMATELY 500.00' TO THE LEFT; THENCE WEST AN APPROXIMATE DISTANCE OF 640.00' BACK TO THE POINT OF BEGINNING, AND CONTAINING 6.91 ACRES, MORE OR LESS.

THAT PART OF THE SW $\frac{1}{4}$ SE $\frac{1}{4}$ OF SECTION 10, TOWNSHIP 19 NORTH, RANGE 7 EAST OF THE 6TH P.M., DODGE COUNTY, NEBRASKA, LYING NORTH AND EAST OF THE NORTHEASTERLY ROW OF THE C & NW RAILROAD, LESS TAX LOT 16, AND CONTAINING 35.80 ACRES, MORE OR LESS.
