DESCRIPTION OF PARCELS CREATED

## PARCEL 1

A portion of Lot 145 irregular tracts in the NE ½ of Section 34, T10N, R6E, more particularly described as follows: Commencing at the NW corner of said NE ¼, such point being the intersection of centerlines of South Folsom Street and West "A" Street, thence south along centerline of South Folsom Street a distance of 951.85; thence east 50.0' to the point of beginning; thence north a distance of 618.85'; thence east a distance of 154.0'; thence south a distance of 620.58'; thence west a distance of 154.0' to the point of beginning.

- That a single direct vehicular access location to West "A" Street from Parcel 3, as described on attached Exhibit "A", and located inline with the centerline of SW 6th Street is permitted.
- That a single direct vehicular access location to South Folsom Street from Parcel 3, as described on attached Exhibit "A", and located inline with the centerline of West Sumner Circle.

The agreements contained herein shall run with the land described above and shall be binding and obligatory upon the heirs, successors and assigns of the subdivider to all or any part of the real estate as described above.
