

ORDINANCE No. 22717

AN ORDINANCE vacating First North and South alley East of 24th Street from Ohio Street to North Line of East and West alley North of Lake Street, also from Lake Street to South Line of East and West alley South of Ohio Street in the SW $\frac{1}{4}$  of Section 10, Township 15 North, Range 13, East of the 6th P.M., In the City of Omaha and providing the effective date hereof.

WHEREAS, petition representing owners of more than 75 percent of the property abutting on First North and South alley East of 24th Street from Ohio Street to North Line of East and West alley North of Lake Street, also from Lake Street to South Line of East and West alley South of Ohio Street in the SW $\frac{1}{4}$  of Section 10, Township 15 North, Range 13, East of the 6th P.M., has been filed with the City of Omaha; and

WHEREAS, said property owners have in and by said petition waived any and all damages that may be occasioned by said vacation;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. The 1st No. & So. alley East of 24th St. from Ohio St. to No. Line of East & West alley No. of Lake St., also from Lake St. to S. Line of East & West Alley So. of Ohio St. in the SW $\frac{1}{4}$  of Sec. 10, Twp. 15 No., Range 13, East of the 6th P.M., in the City of Omaha, be and is hereby vacated; the vacating of the property herein described, and the reversion thereof, pursuant to applicable laws shall be subject to the conditions and limitations that there is reserved to the Metropolitan Utilities District of the City of Omaha the right to construct, maintain, repair, and renew and operate now existing or hereafter installed water mains, conduits, and other similar services on equipment above, on and below the surface of the ground for the purpose of serving the general public or abutting property; the right so reserved shall also include such lateral connections or branch lines as may be ordered, desired or permitted by the City, and to enter upon the premises to accomplish the above purposes at any and all times.

Section 2. That this ordinance shall take effect and be in force after 15 days from and after its passage.
