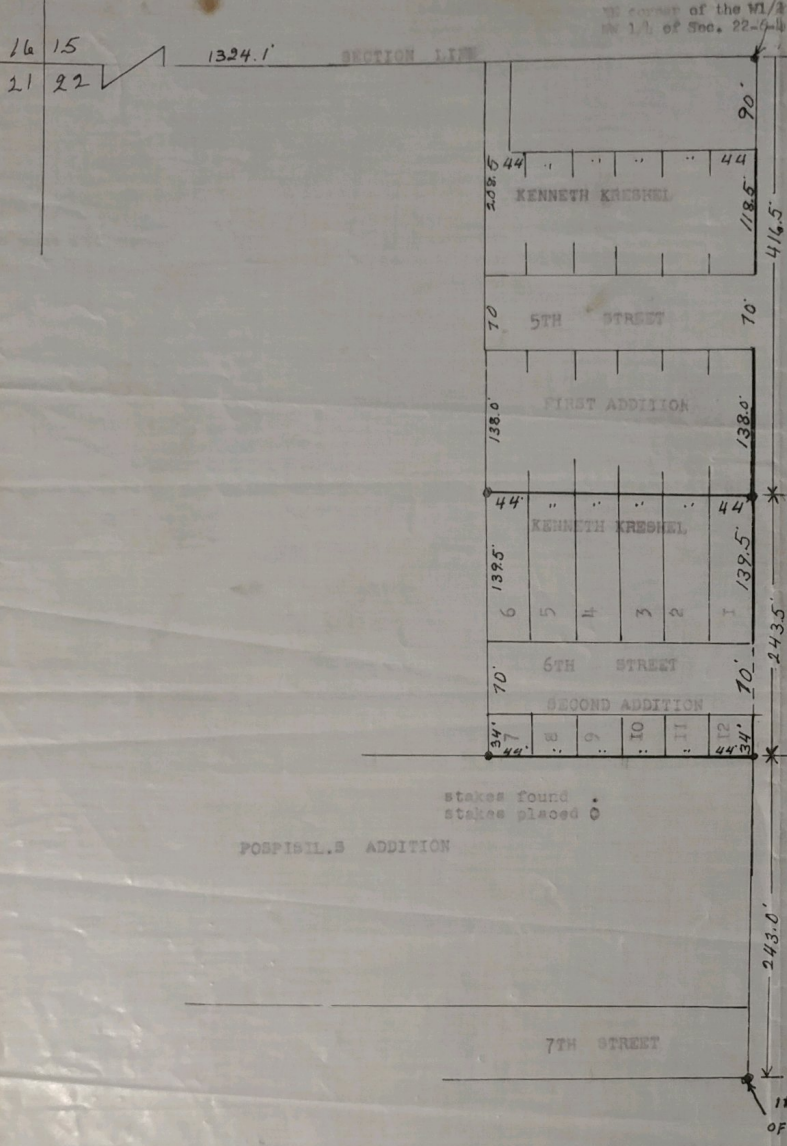


TO THE CITY OF WILBER NEBRASKA

A PART OF THE NW 1/4 OF THE NW 1/4 OF SECTION 22, TOWNSHIP 6 N, RANGE 4 E EAST OF THE SIXTH P.M.



Commencing at a point 416.5 feet south of the northeast corner of the west half of the northwest quarter of section 22 T 6 N, R 4 E, thence west perpendicular with the east line of the west half of the northwest quarter 264.0 feet, thence south parallel with the east line of the west half of the northwest quarter 243.5 feet, thence east parallel with the north line of the northwest quarter 264.0 feet, thence north 243.5 feet to the place of beginning. Lots 1 to 6 are 44 by 139.5 feet, lots 7 to 12 are 44 by 34 feet.

The foregoing subdivision of a part of the Northwest Quarter (NW 1/4) of Section Twenty-two (22), Township Six (6) North, Range Four (4) East, in Saline County, Nebraska, described as follows:

Commencing at a point four hundred and sixteen and one half (416.5) Feet South (S) of the Northeast (NE) corner of the West Half (W 1/2) of the Northwest Quarter (NW 1/4) of Section Twenty-two (22), Township Six (6) North, Range Four (4) East, thence West (W) perpendicular with the East (E) line of the West Half (W 1/2) of the Northwest Quarter (NW 1/4) Two hundred and sixty-four (264.0) Feet, thence South (S) parallel with the East (E) line of the West Half (W 1/2) of the Northwest Quarter (NW 1/4) Two hundred and forty-three and one half (243.5) Feet, thence East (E) parallel with the North (N) line of the Northwest Quarter (NW 1/4) Two hundred and sixty-four (264.0) Feet, thence North (N) Two hundred and forty-three and one half (243.5) Feet to the place of beginning.

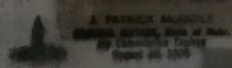
