ORDINANCE NO. 3/0

AN ORDINANCE OF THE CITY OF WILBER, NEBRASKA, ANNEXING
TO AND INCLUDING WITHIN THE CORPORATE LIMITS OF THE CITY OF
WILBER, NEBRASKA, CONTIGUOUS AND ADJACENT LANDS, LOTS, TRACTS
AND STREETS, BEING PORTIONS OF THE WEST HALF (W1) OF SECTION
TWENTY-TWO (22), TOWNSHIP SIX NORTH (6N), RANGE FOUR (4) EAST
OF THE 6th P.M. IN SALINE COUNTY, NEBRASKA, SAID PORTIONS BEING
URBAN AND SUBURBAN IN CHARACTER AND NOT AGRICULTURAL LANDS
WHICH ARE RURAL IN CHARACTER; PROVIDING FOR THE FILING AND
RECORDING OF A MAP OR PLAT OF THE AREA ANNEXED, AND PROOF
OF PUBLICATION OF THIS ORDINANCE; REPEALING ANY PRIOR ORDINANCES
IN CONFLICT HEREWITH; AND PRESCRIBING THE TIME WHEN THIS
ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, NEBRASKA:

SECTION I. The following described lands, lots, tracts and streets located in the West Half (W_2^1) of Section Twenty-two (22), Township Six North (6N), Range Tour (4), East of the 6th P.M. in Saline County, Nebraska which are hereby found to be urban and suburban in character and not agricultural lands which are rural in character, and which are contiguous and adjacent to the present corporate limits of the City of Wilber, Nebraska, are hereby annexed to and included within the corporate limits of the City of Wilber, Nebraska:

Commencing at a point Four hundred and sixteen and one half (416.5) Feet South (S) of the Northeast (NF) corner of the West Half (W_2^1) of the Northwest Quarter (NW1) of Section Twenty-two (22), Township Six (6) North, Runge Four (4), East, thence West (W) perpendicular with the East (E) line of the West Half $(W^{\frac{1}{2}})$ of the Northwest Guarter $(NW^{\frac{1}{1}})$ Two hundred and sixty-four (204.0) Feet, thence South (E) parallel with the Fast (E) line of the West Half (W1) of the Northwest Quarter (NW1) Two hundred and forty-three and one half (243.5) Feet, thence East (E) parallel with the North (N) line of the Northwest Quarter (NW1) Two hundred and sixty-four (264.0) 1 cet, thence North (N) Two hundred and forty-three and one half (243.5) Feet to the place of beginning.

SECTION 2. Upon passage and publication of this Ordinance, as provided by law, the City Clerk shall file and cause to be recorded with the County Clerk of Saline County, Nebraska, an accurate map or plat of the territory annexed, as more particularly described in Section one hereof, certified by Carl Engel, Licensed Surveyor No. 35, and shall file and cause to be recorded with the County Clerk of Saline County, Nebraska, proof of publication of this Ordinance.

SECTION 3. All prior ordinances or portions thereof in conflict herewith are hereby repealed.

SECTION 4. This Ordinance shall take effect and be in full force from and after its passage, approval and publication as required by law.
