AGREEMENT

THIS AGREEMENT, made this 23 day of JANVARY, 1979, between TRI-FEDERAL SAVINGS AND LOAN ASSOCIATION, of Wahoo, Nebraska, Saunders County, and DONALD E. FREDERICK and CAROLINE FREDERICK, husband and wife, and EDWARD J. FREDERICK and PHYLLIS FREDERICK, husband and wife, 106 No. McKenna Ave., Gretna, Sarpy County, Nebraska.

The parties have an interest in adjoining real estate situated in:

The Northwest Quarter of the Northeast Quarter of Section 36, Township 14 North, Range 10 East of the 6th P.M. in Sarpy County, Nebraska, and described respectively as follows:

Along a 30 foot strip, 15 feet either side of a line along the West and South boundary of the following described real estate:

That part of the Northwest Quarter of the Northeast Quarter of Section 36, Township 14 North, Range 10 East of the 6th P.M., Sarpy County, Nebraska, more particularly described as follows: Commencing at the Northeast corner of Lot 247, West Plains, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska; thence N 0° 02' W along the West R.O.W. line of U. S. Highway No. 6 for 322.45 feet to the true point of beginning; thence continuing N 0° 02' W for 175.00 feet to the South R.O.W. line of the County road; thence N 89° 56' 40" W for 120.00 feet along said South R.O.W. line; thence S 0° 02' E for 175.00 feet; thence S 89° 56' 40" E for 120.00 feet to the true point of beginning. (The West R.O.W. line of U.S. Highway No. 6 assumed N 0° 02' W in direction.)

The parties to the Agreement desire to create a common road-way along the above described adjoining land owned by them for the benefit of each of them.

An easement for a common road-way in favor of each of the parties to this Agreement, which said easement shall be 30 feet in width, shall specifically allow traffic to proceed in a traditional driver to the right of the center line traffic pattern for the purpose of creating a common road-way 30 feet in width for the benefit of both of the above described parties. That in addition, the parties to this Agreement agree to share equally the cost of surfacing said right-of-way and to share equally the cost of maintaining said roadway.

This easement is superior and paramount to the rights of any of the parties hereto in the respective servient estates so created, and the parties further agree that it is a covenant that shall run with the land.
