MEMORANDUM OF SUBLEASE

THIS MEMORANDUM, made and entered into this 31 day of January, 1986, by and between NASH-FINCH COMPANY, a Delaware corporation, hereinafter called "Sublessor", and FREDERICK BROTHERS, INC., a Nebraska corporation, hereinafter called "Sublessee",

WITNESSETH:

- 1. The parties have entered into a Sublease Agreement (the "Sublease") dated November 4, 1985, covering the real estate described in Exhibit "A" annexed hereto (the "Leased Premises") together with all buildings and improvements thereon and all appurtenances thereto. The Sublease is hereby incorporated by reference and made a part hereof as if fully set forth herein.
- 2. The term of the Sublease commences on November 4, 1985 and ends on November 3, 2000, and Tenant is granted options to renew the term of the Sublease which, if all such options are exercised, will extend the term of the Sublease to November 3, 2010.
- 3. The Sublease grants and gives Sublessee all rights and privileges given Sublessor including, but not limited to, the irrevocable first right and option to purchase and first right of refusal to lease the vacant land adjacent to the Leased Premises more particularly described in Exhibit "B" annexed hereto, at any time during the term of the Sublease, under the terms and conditions granted Sublessor.
- 4. In the event of any conflict or inconsistency between the terms of this Memorandum and the terms of the Sublease, the terms of the Sublease shall control.


