AFFIDAVIT OF CORRECTION

This Affidavit is made to correct an error of omission in City Ordinance 36725, recorded as instrument number 2004113457, in the Douglas County Register of Deeds office. In the legal description for the right of way vacation for part of Northwest radial Highway abutting Lots 19 through 24, Block 11, BENSON, a subdivision, as surveyed, platted and recorded in Douglas County, the omitted course is underlined and italicized in the following corrected legal description:

That part of the Northwest Radial Highway right of way lying south of and abutting the present south line of Lots 19 through 24, inclusive, Block 11, BENSON, a subdivision, as surveyed, platted and recorded in Douglas County, Nebraska and approximately 12.5 foot north of the north back of curb for the

paving on the highway, described as follows:

Commencing at the northwest corner of said Lot 19;

Thence South 01°09'57" East (assumed bearings) for 74.57 feet along the west line of said Lot 19 to the north right of way line of the Northwest Radial Highway and the TRUE POINT OF BEGINNING; Thence east along said north right of way line for the next seven (7) courses:

Thence South 87°10'11" East for 50.18 feet to the east line of said Lot 19;

- Thence South 87°46'40" East for 49.85 feet to the east line of said Lot 20; (2)
- Thence South 87°35'06" East for 14.03 feet to the west line of said Lot 21; (3)

- Thence South 79°21'41" East for 50.68 feet to the east line of said Lot 22; (5)
- Thence South 79°28'56" East for 44.74 feet to an angle in said Lot 23; (6)
- Thence South 58°10'01" East for 7.74 feet to the east line of said Lot 23;

Thence South 89°41'12" West for 59.85 feet approximately 12.5 feet north of the existing north back of curb of the paving on the highway,

Thence North 89°46'14" West for 124.06 feet approximately 12.5 feet north of the existing north back of curb of the paving on the highway;

Thence along a curve to the right (having a radius of 399.50 feet and a long chord bearing North 85°02'43" West for 65.82 feet) for an arc length of 65.89 feet to the extended west line of said Lot 19;


