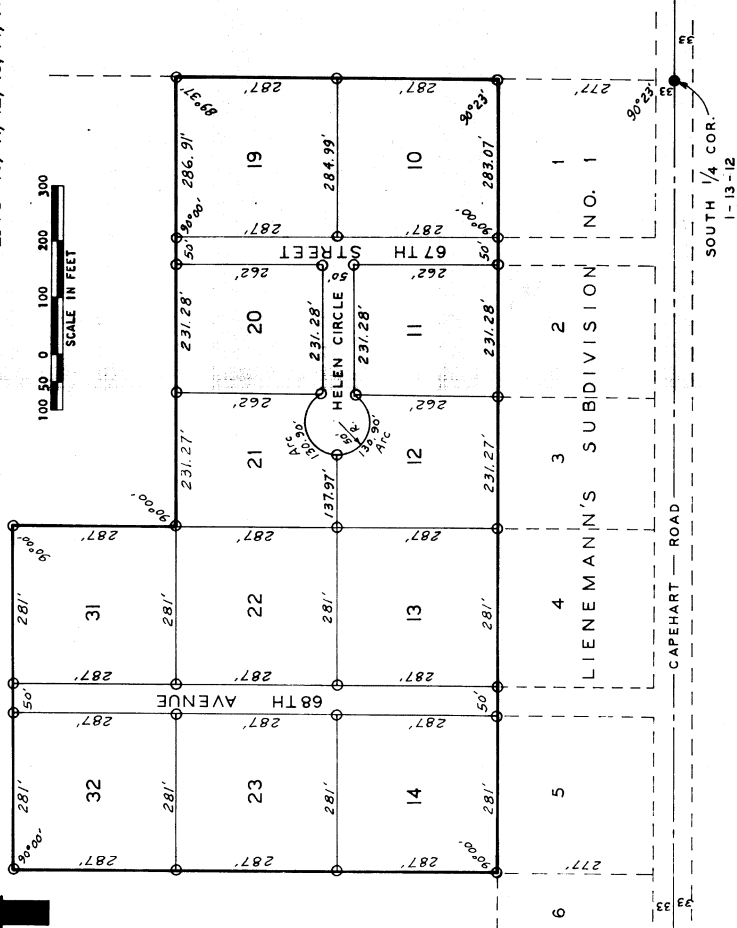

TO THE POINT OF BEGINNING; THENCE NORTH 00 DEGREES 23 MINUTES EAST 74.00 FT. ALONG THE EAST LINE OF THE SOUTH WEST QUARTER OF SAID SECTION 13, THENCE S 89 DEGREES 52' 11" W 1407.52 FT. TO THE POINT OF BEGINNING.

KNOW ALL MEN BY THESE PRESENTS: THAT WE, HERBERT H. LIENEMANN AND HELEN A. LIENEMANN, HUSBAND AND WIFE, OWNERS AND PROPRIETORS OF THE LAND DESCRIBED IN THE SURVEYOR'S CERTIFICATE ON THIS PLAT, HAVE CAUSED SAID LAND TO BE SURVEYED AND STAKED AS SHOWN ON THIS PLAT, PUBLIC DEDICATION TO THE CITY OF PAPIILLON, NEBRASKA, AND THE LOTS NUMBERED AS SHOWN, AND WE DO HEREBY DEDICATE TO THE CITY OF PAPIILLON, NEBRASKA, SADDLE CREEK, AND WE DO ALSO DEDICATE A PUBLIC EASEMENT OVER AND ACROSS THE FRONT FIVE FEET OF EACH LOT FOR FUTURE WATER LINES. WE DO HEREBY DEDICATE A PERPETUAL EASEMENT TO THE OMAHA PUBLIC POWER DISTRICT AND THE NORTHWESTERN BELL TELEPHONE COMPANY, TO THE SUCCESSORS AND ASSIGNS, TO ERECT, OPERATE, MAINTAIN, REPAIR, AND RENEW POLES, WIRES, CABLES, CONDUITS, AND REAR LOT LINES, AND PERMANENT BUILDINGS, AND TO CROSS A FOOTING STRIP OF LAND ABUTTING ALL SIDES OF SAID LOTS, GARDENS, SHRUBS, LANDSCAPING, AND OTHER PURPOSES THAT DO NOT THEN OR LATER INTERFERE WITH THE AFFORSAID RIGHTS HEREIN GRANTED.
