A tract of land located in the Southwest Quarter of Section 35, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Beginning at the center quarter corner of said Section 35; thence southerly on the East line of the Southwest Quarter of said Section 35 a distance of 118.2 feet; thence westerly 99 degrees 26 minutes right a distance of 713.0 feet; thence continuing westerly 11 degrees 36 minutes left a distance of 1861.5 feet to a point 71.6 feet southerly from the North line of said Southwest Quarter; thence northerly a distance of 71.6 feet to a point on said North line; thence easterly on said North line a distance of 2563.9 feet to the point of beginning, containing 2.52 acres, more or less.

Also a tract of land located in part of the Northwest Quarter of Section 35, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Beginning at the center quarter corner of said Section 35; thence westerly on the South line of the Northwest Quarter of said Section 35 a distance of 2563.9 feet; thence northerly 90 degrees 00 minutes right a distance of 193.4 feet; thence easterly 91 degrees 42 minutes right a distance of 1861.4 feet to a point of curvature; thence continuing easterly on a 2914.79 foot radius curve to the right (initial tangent of which forms an angle of 1 degree 42 minutes left with the last described course produced) a distance of 710.6 feet to a point on the East line of said Northwest Quarter; thence southerly on said East line a distance of 66.1 feet to the point of beginning, containing 9.27 acres, more or less.

There will be no ingress or egress onto the remaining lands of the grantor over the above described tracts.

The grantors hereby retain and reserve for themselves, their heirs, successors or assigns all mineral rights in the above described real estate. The grantors, their heirs, successors or assigns shall have no right to use or enter the surface of the above described real estate for any purpose concerning the reserved mineral rights; nor shall the grantors, their heirs successors or assigns in extracting such minerals damage or in any way impair the use of the above described real estate. 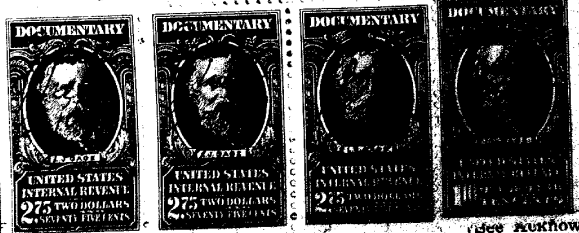

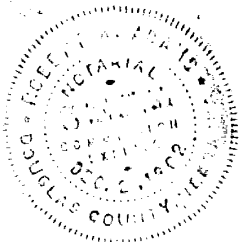
