organized and existing under and by virtue of the laws of the State of Nebraska hereinafter known as the Grantor, for and in consideration of the sum of -----One and 00/100-----(\$1.00)----- DOLLARS in hand paid, does hereby grant, bargain, sell, convey and confirm unto THE STATE OF NEBRASKA, the following described real property situated in Sarpy County and State of Nebraska:

A tract of land located in the southerly part of the Top of the Mark Addition in the South Half of the Northwest Quarter of Section 35, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Referring to the West Quarter Corner of said Section 35 and assuming the West Line of said Section 35 to be due North; thence on an azimuth of 90 degrees 19 minutes and on the South Line of said South Half of the Northwest Quarter a distance of 942.9 feet; thence on an azimuth of 00 degrees 19 minutes a distance of 172.7 feet to the point of beginning, said point being on the northerly existing State Highway Number 370 Right of Way Line; thence on an azimuth of 01 degree 41 minutes a distance of 0.7 feet; thence on an azimuth of 90 degrees 00 minutes a distance of 997.4 feet to point of curvature; thence on a 2,974.79 foot radius curve to the right (azimuth of the initial tangent being 90 degrees 00 minutes) a distance of 383.0 feet, subtending a central angle of 07 degree 23 minutes to a point on the westerly property line of Cedardale Cemetary; thence on an azimuth of 180 degrees 30 minutes and on said property line a distance of 30.2 feet to a point on said existing Highway Right of Way Line; thence on a 2,944.79 foot radius curve to the left (azimuth of the initial tangent being 277 degrees 27 minutes) and on said existing Highway Right of Way Line a distance of 382.78 feet, subtending a central angle of 07 degrees 27 minutes; thence on an azimuth of 271 degrees 41 minutes and on said existing Highway Right of Way Line a distance of 997.9 feet to the point of beginning, containing 26,801.59 square feet, more or less, being the area hereby secured.

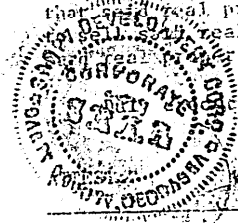
There will be no ingress or egress over the above described tract onto the remainder of said Top of the Mark Addition, except over one entrance for Street purposes, not to exceed 40 feet in width, the centerline of which located 1,615.0 feet easterly from the West Line of the South Half of the Northwest Quarter as measured along the centerline of the highway.

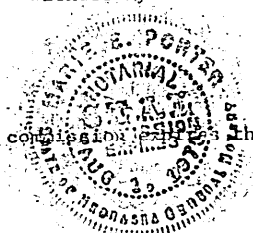
