in hand paid do hereby grant, bargain, sell, convey and confirm unto THE STATE OF NEBRASKA the following described real estate situated in Sarpy County, and State of Nebraska, to-wit:



A tract of land located in the Southeast Quarter of Section 27, Township 14 North, Range 11 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Referring to the southeast corner of said Section 27; thence westerly on the South line of the Southeast Quarter of said Section 27 a distance of 1,263.5 feet; thence northerly 90 degrees right a distance of 33.0 feet; thence easterly a distance of 363.4 feet to a point 86.5 feet northerly from said South line; thence continuing easterly a distance of 550.0 feet to a point 88.5 feet northerly from said South line; thence northeasterly 44 degrees 03 minutes left a distance of 1,294.5 feet, more or less, to a point 33.0 feet westerly from the East line of said Southeast Quarter; thence easterly 44 degrees 38 minutes right and on a line perpendicular to said East line a distance of 33.0 feet to a point on said East line; thence southerly on said East line a distance of 992.0 feet to the point of beginning, containing 13.61 acres, more or less, which includes 2.14 acres, more or less, previously occupied as a public highway, the remaining 11.47 acres, more or less, being the additional acreage hereby secured.


