 in Madison County and State of Nebraska and subject to any and all existing restrictions and/or easements:

One unrestricted access, for public use, not to exceed 40.0 feet
 in width, the centerline of which is located 195.9 feet northwesterly
 from the East Line of the Southwest Quarter of Section 28, Township
 24 North, Range 1 West of the 6th P.M., Madison County, Nebraska,
 as measured along the centerline of the highway and being on the
 southwesterly side of said Highway.

It is the intention of the parties that this Quitclaim Deed will
 convey a right of ingress and egress for the proposed connection
 of 20th Street and U.S. Highway No. 275 bypass; that this conveyance
 opens the control of access for the above described 40.0 feet on
 the southwesterly side of U.S. Highway No. 275; and that the
 control of access remains unchanged except for the point of
 ingress and egress described in this conveyance.
