E A S E M E N T

THIS INDENTURE, Made this 2 day of May,  
1963; between Grace Bartels, a widow,

hereinafter called the Grantors, whether one or more, and The State  
of Nebraska, hereinafter called the Grantee:

WITNESSETH, That the Grantors, in consideration of the sum  
of Twenty-Five and 00/100 - - - - - (\$25.00) - - - - DOLLARS  
in hand paid, the receipt of which is hereby acknowledged, and the  
further consideration that the premises herein conveyed shall be  
used for the control of outside advertising signs, displays, and  
other advertising devices adjacent to the National System of Inter-  
state and Defense Highways, do hereby grant, convey, and confirm  
unto the Grantee a permanent easement in and to a tract of land  
situated in Sarpy County, Nebraska, described as  
follows:

All that part of the Northeast Quarter of Section 24,  
Township 14 North, Range 11 East of the 6th P.M., Sarpy County,  
Nebraska, lying within 660 feet of the Interstate Highway Right  
of Way Controlled Access lines as measured at right angles to the  
centerline of said Interstate Highway, and being in accordance  
with the provisions of Section 84-907 R.R.S., 1943; approved and  
filed on June 15, 1961, and as illustrated on the attached plat.

RECORDED IN SARPY COUNTY DEEDS, SECTION 1963 AT 9, CLOTHESLINE A;  
AND RECORDED IN BOOK 475 OF PLAT PAGE 23 Blue Benten REGISTER OF DEEDS

The Grantors, for themselves, their heirs, successors and  
assigns, do hereby covenant with the Grantee and its assigns, that  
the Grantors are lawfully seized of said premises and that the  
Grantors have good right and lawful authority to convey said  
permanent easement; and that the Grantors warrant and will defend  
the title to said premises against the lawful claims of all per-  
sons whomsoever.


