DESCRIPTION OF THE PROPOSED FIBER OPTIC CABLE ROUTE IN THE NORTHEAST QUARTER (NE%) OF SECTION TWENTY FOUR, TOWNSHIP FOURTEEN (14) NORTH, RANGE ELEVEN (11) EAST OF THE SIXTH (5th) P.M., SARPY COUNTY, NEBRASKA

An easement 16.5 feet in width, the boundaries of which are 3 feet left and 13.5 feet right of the following described centerline of proposed buried cable in Section 24, T14N, R11E, of the 6th P.M. in Sarpy County, Nebraska.
