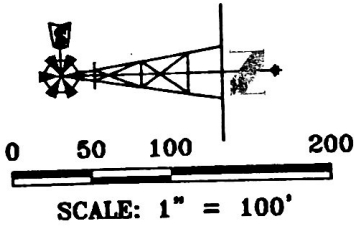


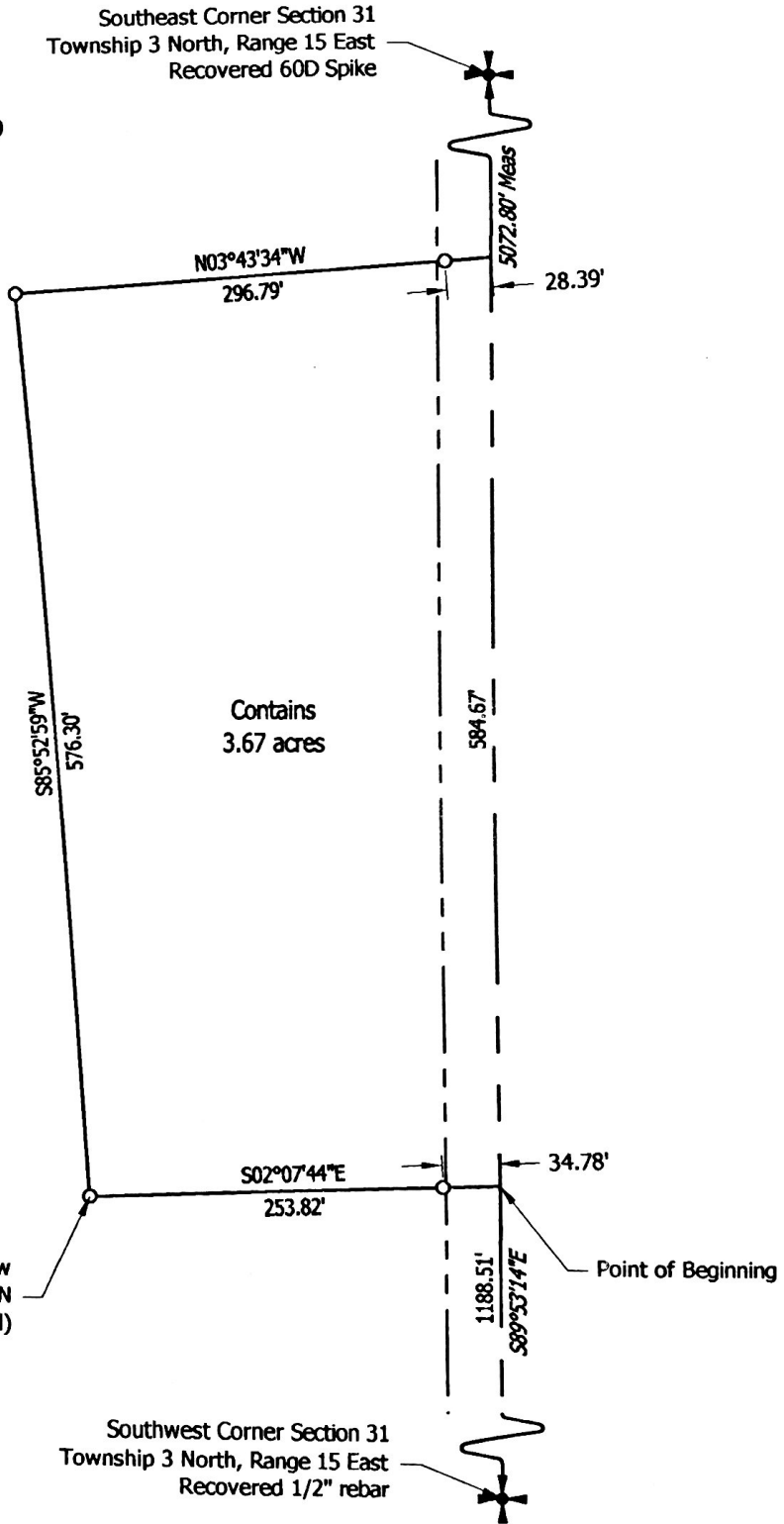
BOUNDARY SURVEY

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF RICHARDSON COUNTY, NEBRASKA, TO APPROVE CONVEYANCES OF TRACTS OF LAND AND CONSTITUTING SUBDIVISIONS AND RE-SUBDIVISIONS.

BE IT RESOLVED BY THE COUNTY COMMISSIONERS OF THE COUNTY OF RICHARDSON, NEBRASKA, that the described subdivision or re-subdivision of lots or tracts of land, dividing the following described tract of land:

A tract of land located in the Southwest One-Quarter of Section 31, Township 3 North, Range 15 East of the Sixth Principal Meridian, Richardson County, Nebraska, being more particularly described as follows:

Creating the following subdivision:

Commencing at the Southwest Corner of said Section 31; thence S89°53'14"E and along the South line of said Southwest One-Quarter a distance of 1188.51 feet to the Point of Beginning, Thence S89°53'14"E and along the South line of said Southwest One-Quarter a distance of 584.67 feet; Thence N03°43'34"W a distance of 296.79 feet; Thence S85°52'59"W a distance of 576.30 feet; Thence S02°07'44"E a distance of 253.82 feet to the Point of Beginning, containing 3.67 acres, of which 0.44 acres is contained in County Right-of-Way.

Completed within the jurisdiction of the County of Richardson, Nebraska, should be made and is hereby approved by the County Commissioners of the County of Richardson; and that a copy of this Resolution shall be filed with the County Clerk of Richardson County, Nebraska.
