I, MARIE A. STUBBENDECK, a resident of Unadilla, Otoe County, Nebraska, being of sound mind and disposing mind and memory, do hereby make, publish, and declare this to be my Last Will and Testament, revoking all former Wills and Codicils made by me.

I.

I declare that my domicile is Unadilla, Nebraska. I have seven children, namely: Kathryn A. Vader, Donald O. Stubbendeck, Janis M. Johnson, Daryl L. Stubbendeck, Loren G. Stubbendeck, Clark A. Stubbendeck, and Roger D. Stubbendeck.

II.

I direct that all my just debts, funeral expenses, and expenses of administration of my estate, including all inheritance, estate, and succession taxes (including interest and penalties thereon) payable by reason of my death, owing at the time of my death, and which may become payable upon or with respect to any property included in my estate, shall be paid from my revocable trust dated the 27th day of February, 1998; provided, however, that payment of any debt secured by a mortgage or pledge of real estate or personal property may be postponed by my Personal Representative in his or her absolute discretion.

III.

I give and devise all of the rest, residue, and remainder of my estate, of whatever kind and wherever situated, to the Trustee under a certain revocable Trust Agreement dated the 27th day of February, 1998, between myself as Grantor and myself as Trustee, to be added to and commingled with the trust property of that trust, and held, administered, and distributed in accordance with the provisions of that agreement and any amendments made to it pursuant to its terms before my death as if it had been a part thereof immediately before my death.

My Personal Representative shall have, with respect to the affairs and property of my estate, all those powers conferred to a Personal Representative in Article 24, Part 7 of the Nebraska Probate Code, as of the date of the execution of this my Last Will and Testament. My Personal Representative may exercise such powers without giving bond or surety, or without court order, in such manner and as such Personal Representative shall determine. I hereby expressly authorize my Personal Representative to execute deeds of conveyance to any and all real estate which I may own without obtaining authority or order from any court. My Personal Representative shall have full power and absolute discretion to distribute my estate, either in cash or in kind.



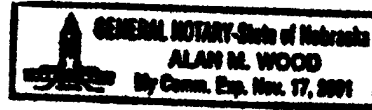
