EASEMENT

WHEREAS, the party of the first part owns and has title to the real estate situated in Douglas County, State of Nebraska, described as follows:

A tract of land in the Southwest Quarter of Section 7, Township 15 North, Range 11 East of the 6th P.M., Douglas County, Nebraska, more particularly described as follows: Commencing at a point on the north line of the Union Pacific Railroad right-of-way 253.0 feet southeasterly from the east line of Tax Lot 3 in said Section 7; thence southeasterly along the Union Pacific Railroad right-of-way a distance of 150.0 feet; thence northwesterly deflection angle left 90° 00' a distance of 20.0 feet; thence northwesterly deflection angle left 90° 00' a distance of 150.0 feet; thence southwesterly deflection angle left 90° 00' a distance of 20.0 feet to the place of beginning containing 0.1 acre more or less.
