SPECIAL SECURITY DEED

FIRSTIER BANK, NATIONAL ASSOCIATION, OMAHA, NEBRASKA, A National Banking Association, Successor in Interest to First National Bank & Trust Company of Fremont, Fremont, Nebraska, organized under the laws of the United States, Grantor, in consideration of Ten Dollars (\$10.00) and Other Good and Valuable Consideration received from Grantee, conveys to Grantee,

Robert W. Burkley and Karen T. Burkley, Husband and Wife, Joint Tenants, VPOS

the following described real estate (as Defined in Nebr. Rev. Stat. 76-201):

That part of the Southwest Quarter of the Southwest Quarter of Section 30, Township 15, Range 7, Saunders County, Nebraska, described as commencing at a point 33 feet East of the Southwest corner of said SW₄, thence North 1000.89 feet, thence East deflection angle 90°07' a distance of 406 feet, thence Northwestwardly to a point lying 1056 feet North and 458.72 feet East of the Southwest corner of said Section, thence Easterly to a point lying 258 feet South and 538 feet East of the Northwest corner of said Quarter Quarter Section, thence North to a point on the North line of the SW₄ SW₄, which point is 533 feet East of the Northwest corner of the SW₄ SW₄, thence East on said line to the West line of the right of way of the F.E. & M.V. R.R. Co., thence Southwesterly along said right of way line to the South line of said SW₄, thence West to the place of beginning; EXCEPT a tract commencing at a point on the South line of said SW₄, said point being 33 feet east of the SW corner thereof, thence northerly deflection angle 90°47'27" left on a line parallel to the west line of said SW₄ a distance of 182.0 feet, thence easterly deflection angle 90°47'27" right a distance of 143.95 feet to a point on the Westerly line of the Chicago Northwestern Railroad right of way line; thence southwesterly on a curve along said right of way line having a chord distance of 186.50 feet to a point on the South line of said SW₄, thence West on said South line a distance of 101.82 feet to the place of beginning; ALSO EXCEPT a tract commencing at a point on the North line said SW₄ SW₄, said point being 531.60 feet East of the Northwest corner said SW₄ SW₄, this being the NE corner of the Greenwood Cemetery and also being the true place of beginning; thence N89°38'31"E along said north line SW₄ SW₄, 293.66 feet to the west line of the abandoned C & M Railroad right of way; thence southerly on said west right of way line, on a 3184.91 feet radius curve to the left 321.85 feet, the chord of said curve bears S37°41'03"W; thence S88°28'21"W, 89.88 feet to the Southeast corner Greenwood Cemetery; thence N01°28'01"W along the east line Greenwood Cemetery, 255.25 feet to the place of beginning.

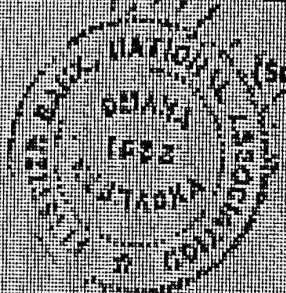
Grantor covenants (jointly and severally, if more than one) with Grantee that Grantor:

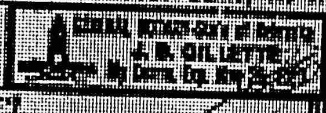
