AMENDMENT TO PROTECTIVE COVENANTS

THIS AMENDMENT TO PROTECTIVE COVENANTS is made the date hereinafter set forth by Celebrity Homes, Inc., a Nebraska corporation ("Declarant").

RECITALS

- A. On October 11, 2001, a document entitled Protective Covenants (hereinafter the "Declaration") for Lots One (1) through Three Hundred Twenty-two (322), inclusive, and Lots Three Hundred Twenty-nine (329) through Four Hundred Eighty-eight (488), inclusive, in COYOTE RUN, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska, was recorded by Declarant, in the office of the Register of Deeds of Douglas County, Nebraska as Miscellaneous Book 1402 Pages 695 699.
- B. Paragraph 20 of the Declaration provides that the covenants and restrictions of the Declaration may be amended by the Declarant for a period of 10 years following October 10, 2001.

NOW, THEREFORE, Declarant hereby declares that the Declaration recorded on October 11, 2001 at Miscellaneous Book 1402 Pages 695 - 699 in the office of the Register of Deeds of Douglas County, Nebraska should be and hereby are amended in the following manner:

- 1. By deleting therefrom Paragraph 5 and adding in its place and stead the following:
 - 5. <u>Fences and Dog Runs.</u> Fences shall not be located on any lot nearer to the street than the structure located on said lot. Any fence installed on any Lot by the Developer shall be maintained by the owner of such Lot, at the owner's sole expense and the owner shall keep such fence in good order and repair and replace the same with the same style and equal quality fence when and if reasonably necessary. Owner, if approved pursuant to the requirements of paragraph 14, Architectural Control, may install fencing perpendicular to perimeter fencing only. Chain link fencing is not permitted in any instance. No dog runs shall be permitted.

 All other terms of said Declaration shall remain in full force and effect.
