ML Construction & Design, LLC, a Delaware limited liability company, doing business in Nebraska as MMML, LLC (referred to herein as "ML"), is the contract purchaser of Lot One (1), Lawnfield Replat No. 3, an Addition to the City of Omaha, in Douglas County, Nebraska (referred to herein as "Lot 1").
