

Fee simple title to a tract of land and all improvements thereon, if any, for highway right of way purposes located in part of the West Half of the Southwest Quarter of the Northwest Quarter of Section 1, Township  $1l_1$  North, Range 12 East of the 6th P.M., Douglas County, Nebraska, as illustrated on the attached plat and being more particularly described as follows:




