Cary and Cornelia S. cary (Husband and wife), the grantors hereunder In consideration of Three Hundred Thirty-five and no/100 (\$335.00) DOLLARS. in hand paid, do hereby grant, bargain, sell, convey and confirm unto Hans Anderson, the grantee hereunder the following described real estate, situate in the County of Douglas, and State of Nebraska, to-wit:Lot Seventy-nine (79) in West "L" Street Acres, an addition in Douglas County, Nebraska, as surveyed, platted and recorded. Subject to all regular taxes becoming due, and all installments of special assessments becoming delinquent after the 17th day of February, 1922; subject also to the following restrictions and conditions, to wit: The said premises shall be occupied for residence purposes exclusively from the date hereof until the first day of January A.D. 1930. No dwelling shall at any time prior to the above date be erected thereon with less than four (4) rooms, with shingle roof and drop siding, and be painted, or be of brick, stucco or stone construction, and shall cost at least One thousand dollars (\$1000.00) exclusive of outbuildings, and shall not be nearer to the front line of the lot than twenty-five (25) feet; subject also to the right of the Northwestern Bell Telephone Company and the Nebraska Power Company to place and maintain poles on rear line of said lot.
