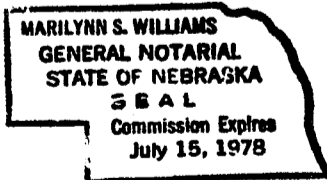

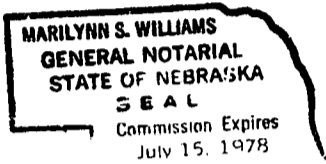

DESCRIPTION

Commencing at a point on the South line of the SE $\frac{1}{4}$ of Section 35, Township 9 North, Range 6 East of the 6th P.M., Lancaster County, Nebraska, said point located 809.58 feet westerly from the Southeast corner of the SE $\frac{1}{4}$ of said Section 35; thence northerly, normal to the south line of the SE $\frac{1}{4}$ of said Section 35, a distance of 50.0 feet, to the point of beginning; thence easterly, parallel with and 50.0 feet northerly from the south line of the SE $\frac{1}{4}$ of said Section 35, a distance of 395.84 feet; thence southwesterly, on an angle of 124° 30' right, a distance of 20.62 feet to a point 33.0 feet northerly from and normal to the South line of the SE $\frac{1}{4}$ of said Section 35; thence westerly, parallel with and 33.0 feet northerly from the south line of the SE $\frac{1}{4}$ of said Section 35, a distance of 222.88 feet; thence northwesterly, on an angle of 6° 01' right, a distance of 162.17 feet, to the point of beginning.
