AMENDMENT OF RIGHT OF WAY GRANT

ANY AND ALL RESTRICTIONS CONTAINED IN SAID RIGHT OF WAY GRANT, OR INFERRED FROM GREAT LAKES PIPE LINE COMPANY'S EXERCISE OF ITS RIGHTS THEREUNDER AS TO THE WIDTH OF THE RIGHT OF WAY, THE LOCATION, DIRECTION AND ROUTE OF THE PIPE LINES, ARE HEREBY DELETED;

IN ALL OTHER RESPECTS SAID GRANT OF RIGHT OF WAY REMAINS UNCHANGED, THE UNDERSIGNED, WHETHER ONE OR MORE, HEREBY WARRANTS THAT HE IS ENTITLED TO RECEIVE THE SUM HEREIN PAID, IS ENTITLED TO AMEND SAID RIGHT OF WAY GRANT AND IS THE OWNER OF THE ABOVE DESCRIBED LAND.
