

1. AN UNDIVIDED ONE-HALF INTEREST IN:

The Fractional North Half of the Northwest Fractional Quarter of Section 30, Township 67 North, Range 27 West of the 5th P.M., Decatur County, Iowa, EXCEPT the South 11.63 acres of the following described parcel of land:

Beginning at a 1-1/4" iron pipe at the N ¼ corner of said Section 30, thence S00°32'49"W along the East line of the NW ¼ of said Section 30 a distance of 1315.57' to a ½" iron pin on the SE corner of the NE ¼ of the NW ¼ of said Section 30, thence N89°24'43"W along the South line of the Fractional N ½ of the NW ¼ of said Section 30 a distance of 951.91' to a ½" iron pin, thence N04°48'22"W a distance of 432.55' to a ½" iron pin, thence S87°29'13"E a distance of 18.52' to a ½" iron pin, thence N04°39'04"W a distance of 422.91' to a ½" iron pin, thence N40°25'22"E a distance of 369.79' to a ½" iron pin, thence N14°14'34"E a distance of 184.96' to a ½" iron pin on the North line of the NW ¼ of said Section 30, thence S89°28'02"E along the North line of the NW ¼ of said Section 30, a distance of 731.21' to the point of beginning.
