ORDINANCE NO. ______**16545**

AN ORDINANCE creating Paving District No. 2596, defining the limits thereof, establishing the width of the roadway to be paved and the width of the grading to be done, providing for the curbing, guttering, and relaying of sidewalks, providing for the payment of the cost thereof, designating the property to be benefited, providing for the acquisition of easements and additional right-of-way, if necessary, and repealing all ordinances or parts of ordinances in conflict herewith.

BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

Section 1. That Paving District No. 2596, of the City of Lincoln, Nebraska, be and the same is hereby created; that said Paving District shall include all that portion of North Coddington Avenue lying between the north line of Surfside Drive and the south line of West "S" Street at Northwest 20th Street, in said City, and the following described real estate benefited, to wit: All that portion of Lots 3 and 4, Block 8, Capitol Beach Manor 2nd Addition, and Lots 65, 85, 99 and 100, all Irregular Tracts located in the south half of Section 21, Township 10 North, Range 6 East of the 6th Principal Meridian, lying between the south line of Surfside Drive and the north line of West "S" Street and lying within 183.0 feet easterly of and westerly of the following described centerline:

Commencing at the intersection with the centerline of North Coddington Avenue and the centerline of Surfside Drive; thence south along the centerline of North Coddington Avenue a distance of 30.0 feet to the point of beginning, also the point of tangency with a circular curve; thence southeasterly along the arc of said circular curve, bearing to the left, whose central angle is 31 degrees 28 minutes 29 seconds, whose radius is 335.62 feet, and whose tangent length in 94.56 feet, a distance of 184.37 feet to the point of tangency with a straight line; thence

continuing southeasterly along the said straight line, a distance of 408.25 feet to the point of tangency with a circular curve; thence southerly along the arc of said circular curve, bearing to the right, whose central angle is 47 degrees 05 minutes 58 seconds, whose radius is 375.0 feet, and whose tangent length is 163.44 feet, a distance of 308.26 feet, to the point of tangency with a straight line; thence south along the said straight line, a distance of 47.93 feet to the point of termination; said point being the intersection with the north line of West "S" Street and the centerline of Northwest 20th Street, all located in the City of Lincoln, Lancaster County, Nebraska.

The roadway to be paved in said district shall be 33.0 feet in width; grading to be from lot line to lot line, and the cost of grading, curbing, guttering, and paving the same, including the cost of grading, curbing, guttering, and paving the returns, and the cost of grading the sidewalk space and relaying of sidewalks and all expenses incidental to all of said improvements shall be assessed against the property benefited in said district in proportion to the benefits, not exceeding the cost thereof. In the event that easements or additional right-of-way must be acquired by negotiation and purchase or by condemnation, if necessary, as provided by law.

Section 2. That all ordinances and parts of ordinances in conflict herewith be and the same hereby are repealed.

Section 3. This ordinance shall take effect and be in force from and after its passage and publication according to law, but construction shall not be commenced until ordered by resolution by the City Council.
