MEMORANDUM OF LEASE

This Memorandum of Lease is made and entered into this 1514 day of October, 2003, by and between The Sioux City Community School District ("Landlord"), whose address is 1221 Pierce Street, Sioux City, Iowa 51105, and Castle on the Hill Limited Liability Company, an Iowa limited liability company ("Tenant"), whose address is 1025 Leavenworth Street, Omaha, Nebraska 68102.

- 1. The parties entered into a Lease dated July 15, 2003, whereby Landlord leased to Tenant the real estate, described on Exhibit "A" attached hereto (the "Leased Premises"), for a term beginning on the 1st day of July, 2003, and terminating on the 30th day of June, 2023, upon the condition that Tenant performs as provided in the Lease. Upon compliance with the terms and conditions of the Lease, the Tenant shall have the right to extend the term of the Lease for two (2) additional five (5) year terms.
- 2. As provided under the terms and conditions of the Lease, during the term of the Lease, Landlord retains a limited right to use the Leased Premises, together with the real property described on Exhibit "B" attached hereto, for parking.
- 3. No assignment or subletting by Tenant, either voluntary or by operation of law, shall be effective without the prior written consent of Landlord, which consent shall not be unreasonably withheld.
