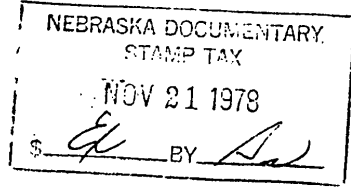


THIS INDENTURE, Made this 9th day of November, in the year one thousand nine hundred and seventy eight, between

In the event that the road abutting any portion of the 17' strip conveyed hereby is abandoned, the title to that portion of the 17' strip abutting the abandoned road shall revert to and vest absolutely in said party of the first part, its successors and assigns.

Together with all and singular the hereditaments thereunto belonging. TO HAVE AND TO HOLD the above described premises unto the said grantee and to grantee's heirs and assigns forever so that neither the said grantor, nor any person in his, her or their name and behalf, shall or will hereafter claim or demand any right or title to the said premises or any part thereof, but they and every one of them shall by these presents be excluded and forever barred.

A seventeen (17) foot strip of land in the Southeast Quarter (SE 1/4) of Section 31, Township 16 North, Range 10 East of the 6th P.M., in Douglas County, Nebraska, lying South and West of the Union Pacific Railroad right-of-way; said strip of land being the East 17 feet of the West 50 feet, also the West 17 feet of the East 50 feet, together with the North 17 feet of the South 50 feet of the following described tract of land:

Beginning at the Southeast corner of said Section 31; thence S 90°00'00" W (assumed bearing) along the South line of said SE 1/4 a distance of 2,649.78 feet to the South quarter (S 1/4) corner of said Section 31; thence N 00°07'26" E along the West line of said SE 1/4 a distance 2,138.61 feet to a point on the Southwesterly R.O.W. line of the U.P.R.R.; thence S 52°04'34" E along said Southwesterly R.O.W. line a distance of 178.75 feet to a point of curve; thence Southeasterly along said southwesterly R.O.W. on a curve to the left, said curve having a radius of 11,659.19 feet, a long chord of 1,186.85 feet bearing S 54°59'37" E and an arc length of 1,187.34 feet (chord definition) and 1,187.36 feet (arc definition) to a point of tangency; thence S 57°54'40" E along said Southwesterly R.O.W. line a distance of 1,808.10 feet to a point on the east line of said SE 1/4; thence S 00°01'17" E along said east line of the SE 1/4 a distance of 387.36 feet to the point of beginning. Said strip of land contains 1.96 acres more or less, for roadway purposes only.
