On this \_\_\_\_\_ day of October, 2019, this matter came before the Court for trial. Plaintiff was present and represented by Krista Carlson. Defendant was present and represented by John W. Ballew, Jr. Evidence was adduced and exhibits were marked, offered, and received into evidence. The court, having reviewed the matter, finds as follows:

- 1. **JURISDICTION:** The allegations of Plaintiff's Complaint for Dissolution of Marriage are true. The Court has jurisdiction of the subject matter and the parties to this action. The pleadings reflect that the Defendant entered his appearance voluntarily.
- 2. <u>DISSOLUTION OF MARRIAGE</u>: The parties were married on November 1, 2012, in Lancaster County, Nebraska. The marriage of the parties is irretrievably broken, all efforts at reconciliation have failed, and said marriage should be and is hereby dissolved.

#### 3. PROPERTY SETTLEMENT AGREEMENT:

A Property Settlement Agreement, has been entered into by the parties and was marked as Exhibit and received into evidence. This Court has examined this Agreement and finds it is reasonable and proper in all respects, is not unconsciouable and, accordingly, it is approved, and incorporated within this Decree as if fully set forth.

- 4. RETENTION OF AGREEMENT BY COURT REPORTER: Pursuant to agreement of the parties, the Property Settlement Agreement was marked as an exhibit and offered and received into evidence by this Court at the time of hearing. However, the exhibit was not withdrawn from evidence for purposes of placing it in the permanent court file but was, instead, retained by the court reporter and may be accessed only by either of the parties, their respective lawyers or the Court in the event enforcement of this Decree becomes necessary.
- 5. <u>MERGER OF TEMPORARY ORDER</u>: Sums due and owing under temporary orders that have been entered in this case shall not be merged within and become a part of this Decree.

## IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

I.

The marriage of the parties is hereby dissolved.

II.

The parties have entered into a Property Settlement Agreement, marked as Exhibit and received into evidence which is incorporated herein as if fully set forth. The Court, having examined the Agreement, finds it is reasonable and proper in all respects, is not unconscionable and, accordingly, it is approved. Both parties are ordered to perform and abide by its terms in all manner and respect. Pursuant to agreement of the parties, the Court Reporter shall retain the original Property Settlement Agreement in an envelope which may be assessible by either the parties, their respective lawyers or the Court in the event enforcement of this Decree becomes necessary.

III.

Commencing on the 1st day of October, 2019, Defendant shall pay alimony to Plaintiff in the amount of \$7,000 per month for a period of twenty-four (24) months in accordance with paragraph 5 of the Property Settlement Agreement. Pursuant to agreement of the parties, this Alimony is deductible by Defendant and shall be declarable by Plaintiff as income on the parties' respective income tax returns as a result of the alimony awarded as a continuation of the Temporary Order for a period of twenty-four (24) months. Alimony is terminable upon the death of either party or remarriage of

Plaintiff. The parties have agreed and the Court orders that automatic income withholding pursuant to by NEB. REV. STAT. §43-1718.02 is waived at this time and all payments by Defendant to Plaintiff of alimony shall be paid directly to Plaintiff and not through the Clerk of the District Court as may be allowed under NEB. REV. STAT. §42-369(1). If alimony is not paid in accordance with paragraph 5 of the Property Settlement Agreement, it shall accrue interest at the judgment rate prescribed by NEB. REV. STAT. §45-103 in the amount of 4.095% per annum.

IV.

Defendant is ordered to pay a money judgment to Plaintiff in accordance with paragraph 8 of the Property Settlement Agreement. The amount and details of how that payment is to be made are incorporated within the Property Settlement Agreement as well as the security for said payment. All payments of the money judgment shall be made directly by Defendant to Plaintiff rather than through the Clerk of the District Court for Lancaster County, Nebraska.

V.

Any party to this action ordered to pay a judgment as part of this action is hereby required to furnish to the Clerk of the District Court of Lancaster County, his/her address, telephone number, social security number, the name of his/her employer, whether he/she has access to employer-related health insurance coverage and, if so, the health insurance policy information, and any other information the court deems relevant, until such judgment is paid in full. Any such party is also required to advise the clerk of any changes in such information between the time of entry of the order and the payment of the judgment in full.

In the event a party ordered to pay child, medical and/or spousal support fails to pay such support payment, as such failure is certified each month by the District Court Clerk in cases in which court-ordered support is delinquent in an amount equal to the support due and payable for a one-month period of time, such party may be required to appear in court on a date to be determined by the court and show cause why such payment was not made. In the event such party fails to pay and appear as ordered, a warrant shall be issued for his/her arrest.

This Decree shall become final and operative, except for purposes of review by appeal, without any further action of the court, thirty (30) days from the date this Decree is filed with the court, or upon the death of one of the parties, whichever occurs first. However, for purposes of remarriage or the continuation of health insurance coverage, the Decree becomes final and operative six (6) months from the date the Decree is filed with the Court or upon the death of one of the parties, whichever first occurs. If the Decree becomes final and operative upon the death of either of the parties, the Decree shall be treated as if it became final and operative on the date the Decree is filed with the Court.

VII.

Plaintiff's prior name of Andrea Michelle Hebb should be, and hereby is, restored to her. She will now be known as Andrea Michelle Hebb.

VIII.

To the extent there is any conflict between this Decree and any attachment or other document incorporated herein by reference, the language of this Decree shall supersede and control.
