QUIT CLAIM DEED

THIS DEED, made and entered into by and between MISSOURI PACIFIC RAILROAD COMPANY, a Missouri corporation, herein called "Grantor" and READY MIXED CONCRETE COMPANY, a Nebraska corporation, herein called "Grantee," WITNESSETH:

That the Grantor, for and in consideration of FIVE THOUSAND NINETY AND 44/100 DOLLARS (\$5,090.44), paid by Grantee to Grantor, receipt of which is hereby acknowledged, and of the execution and delivery contemporaneously herewith by Grantee of a Quit Claim Deed conveying to Grantor the following described tract or parcel of land in the City of Omaha, Douglas County, Nebraska to-wit:

All of Lot 12, Block 9, Lots 9, 10, 11, 12, 13, 14 and 15, Block 15, and part of Block 19 Orchard Hill Addition and Public Road, vacated by Ordinance No. 18323 and part of Block 11, Creighton's Second Addition to the City of Omaha, Nebraska described by metes and bounds as follows:

Containing 166,013 square feet more or less.

does by these presents Remise, Release and forever Quit Claim unto the Grantee, its successors and assigns all of said Grantor's right, title and interest in and to the following described tract or parcel of land in the City of Omaha, Douglas County, Nebraska, to-wit:

All of Lot 10, Block 11, Lots 21 and 22, Block 10; parts of Lots 1, 2, 19 and 20 said Block 10, Lot 11 said Block 11, 43rd Avenue (formerly Dale Street) adjoining said Block 10 and 11 and alley in said Block 10, vacated under Ordinance No. 14460 all in Walnut Hill, Omaha, Douglas · County, Nebraska, described by metes and bounds as follows:

Beginning at the Northeast corner of said Lot 11, Block 11; thence Westwardly to the Northwest corner thereof in the Easterly line of said 43rd Avenue; thence Northwardly, along said Easterly line 16 feet to the Southwest corner of said Lot 10, Block 11; thence Eastwardly, to the Southeast corner thereof; thence Northwardly, to the Northeast corner thereof, in the Southerly line of Nicholas Street; thence Westwardly, along said Southerly line 131 feet more or less to a point 45 feet Southeastwardly from and at right angles to the existing center line of the most easterly main track of Missouri Pacific Railroad Company; thence Southwestwardly, by a straight line, parallel with said existing center line to a point in the Southerly line of said Lot 19, Block 10, which is the Northerly line of Izard Street; thence Eastwardly, along said Northerly line 105 feet more or less to a point 9 feet Northeardly from and radially to the existing center line of Grantor's track No. 19-36; thence Eastwardly, 9 feet Northwardly from and concentric and parallel with said existing center line 184 feet more or less to a point in the Easterly line of said Lot 11, Block 11; thence Northwardly 131 feet more or less to the point of beginning. The Grantor herein reserves unto itself, its successors and assigns, all its right, title and interest in and to its tracks known as track numbers 19-34 and 19-35, where now located on the property herein conveyed, together with requisite right of way therefor, with the perpetual right and easement to maintain, repair and renew the same, to operate locomotives, cars and trains on, over and across said tracks, and at any time to remove same from the property herein conveyed.

There is, however, expressly reserved and excepted from this conveyance all coal, oil, gas and the minerals and mineral rights of whatever nature or description, kind or character, like or unlike, known or unknown, and whether occurring in solid, liquid, vaporous or other and different forms, in, on or under the land conveyed hereunder, provided, however, that no operations of investigating, exploring, prospecting, or mining for or storing or transporting said minerals or any of them, shall be conducted or placed upon said premises.

TO HAVE AND TO HOLD the same, together with all rights and appurtenances to the same belonging, unto Grantee, its successors and assigns forever.
