 \$37.50 Dollars in hand paid by the County of Sarpy and
 State of Nebraska, do hereby convey an easement to said
 County in the following described premises situated in said County.

A tract of land containing .13 of an acre in the South-
 west corner of the southwest Quarter of Section 25, Township 14,
 Range 11 making the center of road a regular 28 degree
 curve and being the tract outside the arc of a circle
 having a radius of 173.7 feet outside the present road,
 which easement shall be for the purpose of widening a

(Road Easement)

Know all men by these presents that Joseph Giles of Sarpy County, Nebraska, in consideration of the sum of \$39⁰⁰ Dollars in hand paid by the County of Sarpy and State of Nebraska, do hereby convey an easement to said Sarpy County in the following described premises situated in said County. (Commencing at a point 33 ft north and 213.3 ft. west of the south east corner of Sec. 20 Township 14, Range 13, and running thence north easterly on a curve to the left with radius of 163.7 ft for 257.1 ft to a point 33 ft west of east line of said section, thence south 163.7 ft, thence west 163.7 ft to place of beginning and containing 0.13 acres.) which easement shall be for the purpose of widening a roadway adjacent to said land to increase said roadway in width and to make a more pronounced curve of said road as required by statute for the establishment of a County highway, and said grantors herein consent to the use of the above described strip of land for use as a public highway of said county; to have and to hold said strip of land for use as a highway only, and should such highway be vacated, said described strip of land revert to the owner of said premises.
