

I HEREBY CERTIFY THAT I HAVE ACCURATELY SURVEYED AND STAKED THE FINAL PLAT TO BE KNOWN AS STEWARTVILLE ADDITION; A TRACT OF LAND COMPOSED OF LOTS 27, 28 AND 29, ALL IRREGULAR TRACTS, LOCATED IN THE N. 1/2 OF SECTION 2, T. 8 N., R. 7 E. OF THE 6th P.M., LANCASTER COUNTY, NEBRASKA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

AT THE NW CORNER OF THE E.1/2 OF THE NW 1/4 OF SAID SECTION 2; THENCE SOUTH ON AN ASSUMED BEARING OF SO0°17'19"W, ON THE WEST LINE OF SAID E. 1/2, COMMENCIN 50.00 FEET TO THE NW CORNER OF LOT 29, SAID POINT ALSO BEING ON THE SOUTH RIGHT-OF-WAY OF SALTILLO ROAD AND THE POINT OF BEGINNING; THENCE ON SAID SOUTH RIGHT-OF-WAY LINE FOR 7 COURSES, S89°54'55"E 960.79 FEET; THENCE N00°05'05"E A DISTANCE OF 9.95 FEET; THENCE S89°54'11"E A DISTANCE OF 254.74 FEET; THENCE S00°20'50"E A DISTANCE OF 9.91 FEET; THENCE S89°56'25"E A DISTANCE OF 113.05 FEET, SAID POINT ALSO BEING ON THE WEST LINE OF THE NE 1/4; THENCE S89°55'07"E 1287.12 FEET, THENCE S88°49'46"E 70.36 FEET TO THE NE CORNER OF SAID LOT 27, SAID POINT ALSO BEING ON THE EAST LINE OF THE NW 1/4 OF THE NE 1/4; THENCE S00°55'18"W LEAVING SAID SOUTH RIGHT-OF-WAY LINE AND ON SAID EAST LINE, 840.24 FEET; THENCE S89°54'04"W 1346.79 FEET TO THE SW CORNER OF LOT 27 ON SAID WEST LINE OF THE NE 1/4; THENCE S00°12'19"W ON SAID WEST LINE, 1570.82 FEET TO THE SE CORNER OF SAID E. 1/2 OF THE NW 1/4; THENCE S89°39'20"W ON THE SOUTH LINE OF SAID E. 1/2 OF THE NW 1/4, 1332.44 FEET TO THE SW CORNER OF SAID E. 1/2 OF THE NW 1/4; THENCE N00°17'19"E ON THE WEST LINE OF SAID E. 1/2 OF THE NW 1/4, 2426.57 FEET TO THE POINT OF BEGINNING. DEDICATION

The final plat, known as Stewartville Addition, as described in the surveyors certificate is made with the free consent and in accordance with the desires of the undersigned, the sole owner(s), and the easements shown thereon are hereby granted in perpetuity to the City of Lincoln a Municipal Corporation, and to Lancaster County, Nebraska, and its successors, assigns and permittees, until the final plat is brought within the corporate limits of the City of Lincoln, with respect to storm drains and all appurtenances thereto, to allow entry for the purpose of constructions, reconstructions, repair, operation, and maintenance of wires, cables, conduits, fixtures, poles, towers, pipes, and equipment for the distribution of electricity and gas; telephone and cable television; wastewater collectors; storm drains; water mains and all appurtenances thereto, over, upon, or under the Easements as shown on the final Plat.

The Construction or Location of any building or structure, excluding fences, over, upon, or under any easement shown thereon shall be prohibited.

Lot 1 is limited to only one access to Saltillo Road

The 10.00' Right-of-Way shown hereon along Saltillo Road is hereby dedicated to the public.

The City of Lincoln and Lancaster County, Nebraska, its successors, assigns, and permittees, are hereby held harmless for the cost of replacement or damage to any improvement or vegetation over, upon, or under any easement shown thereon.
