# 2A S S I G N M E N T

KNOW ALL MEN BY THESE PRESENTS: THAT

WHEREAS, NORTHERN NATURAL GAS COMPANY, a Delaware corporation, hereinafter sometimes referred to as "Northern," and PEOPLES NATURAL GAS COMPANY, a Delaware corporation, hereinafter sometimes referred to as "Peoples" entered into an Agreement on August 11, 1948, with the METROPOLITAN UTILITIES DISTRICT of Omaha, a quasi municipal corporation created and existing under the laws of the State of Nebraska, hereinafter sometimes referred to as "District," whereby Northern and Peoples joined to grant District an option to purchase certain pipelines and distribution facilities which are located in certain areas south and west of the City of Omaha, which areas are hereinafter more specifically defined; and,

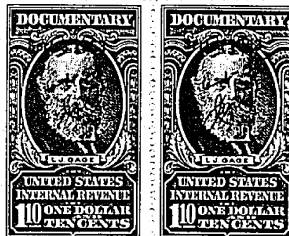
WHEREAS, as of May 31, 1952, Peoples was completely liquidated and dissolved, and Northern succeeded to all of the assets, liabilities and business of Peoples as of the date of said dissolution and liquidation; and,

WHEREAS, District has notified Northern of its desire to purchase those properties and acquire those rights subject to the option thus granted; and

WHEREAS, the Board of Directors of District duly passed a resolution on May 25, 1955, authorizing the purchase of the pipelines and distribution facilities as contemplated by said Agreement of August 4, 1948, together with some additional facilities, for a price mutually agreed upon by the parties.

WHEREAS, included among the properties so sold and purchased are certain right-of-way grants and easement rights; and,

WHEREAS, Northern, concurrently with the execution of this instrument, is executing certain instruments of assignment, transfer and conveyance of various parcels of land, contracts, leases and permits pertaining to those properties which are the subject of this sale.

NOW, THEREFORE; in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Northern does hereby assign, transfer and deliver unto District, its successors and assigns, all of Northern's right, title and interest in and to all easements, rights-of-way, and other rights to lay pipelines and to locate distribution facilities, which easements, rights-of-way, or other rights pertaining to those pipelines and facilities which are the subject of a Bill of Sale from Northern to District of even date herewith and which are more specifically identified in Exhibit "A" attached hereto, which exhibit is incorporated herein and by this reference made a part hereof.

The respective documents by which Northern acquired the rights herein assigned to District shall each be delivered and assigned to the District in manner and form to comply with the laws of the State of Nebraska so as to permit the recording of said assignments with the proper recorder of such instruments.

TO HAVE AND TO HOLD from and after 8:00 A.M. on June 1, 1955 said easements, rights-of-way and other rights to District, its successors and assigns forever.

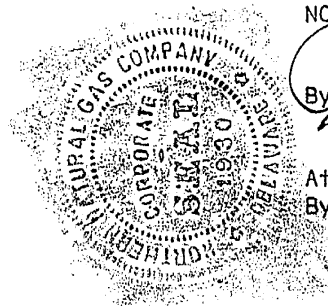
