DECLARATION OF COVENANT AND RESTRICTION FOR LOT 8, MILLARD BUSINESS CENTER

This Declaration is made this day of June 19, 2008, by CLR Development LLC, a Nebraska Limited Liability Company, hereafter referred to as "Declarant",

WHEREAS, Declarant is the sole owner of certain real property in Douglas County, Nebraska, and which is legally described as:

Lot 8, Millard Business Center, an addition to the City of Omaha, Douglas County, Nebraska, (the "Property").

WHEREAS, Declarant desires to provide for the preservation of its obligations under a lease agreement with a tenant of a property adjacent the Property, such leased property is otherwise known as Lot 18, Millard Business Center, and to this end, desires to subject the Property to the covenants, restrictions and easements hereinafter set forth, each of which is for the benefit of the Declarant or any successor in interest or assign;

NOW, THEREFORE, Declarant hereby declares that the Property shall be held, sold and conveyed subject to a restriction that no person, entity or other user of the Property shall engage in any business involving screen printing or other clothing decoration or design.

The Declarant or any successor in interest or assign shall have the right to enforce, by any proceedings at law or in equity, all restrictions, conditions, covenants, reservations, liens and charges now or hereafter imposed by the provisions of this Declaration. Failure to enforce any covenant or restriction herein contained shall in no event be deemed a waiver of the right to do so thereafter. Invalidation of any of these covenants or restrictions by judgment or court order shall in no way effect any other provision which shall remain in full force and effect.

The covenants and restrictions of this Declaration shall run with and bind the land, for a term of ten (10) years from the date of this Declaration is recorded.
