NOW, THEREFORE, Declarant hereby declares that Lots 1, 2, 3 and 4 in Colonial Meadows Plat 5, an Official Plat, now included in and forming a part of the City of Norwalk, Iowa, shall be held, sold and conveyed subject to the Easements, Restrictions, Covenants and Conditions provided for in the Declaration. The submission of said lots as an additional property under the Declaration shall be effective upon the recording of this Supplementary Declaration in the office of the Recorder of Warren County, Iowa.
