

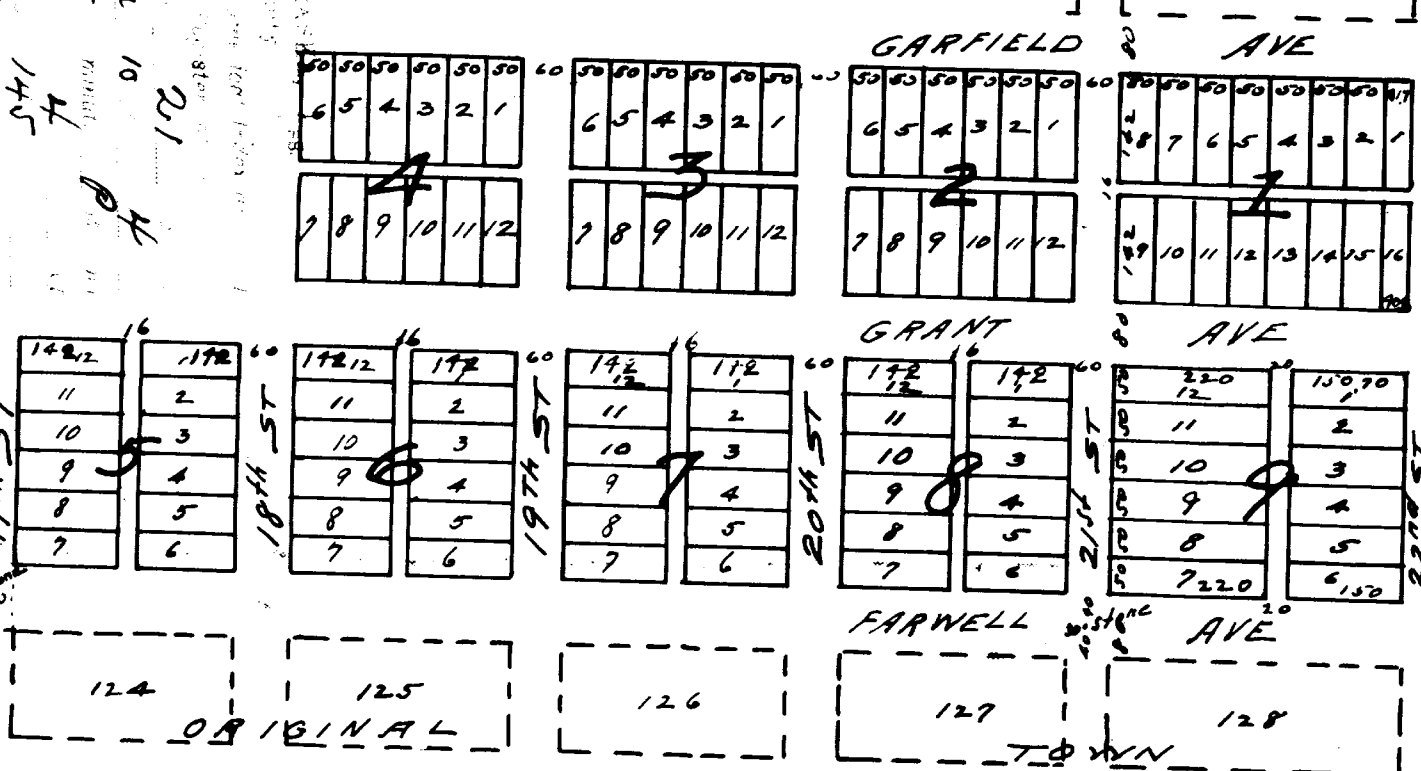
ACKERMAN ADDITION TO HAVELOCK

I hereby certify that on March 12th 1910 I surveyed ACKERMAN ADDITION to Havelock situated on a part of the NE 1/4 of Section 9 T. 10 N. R. 7 E. Block 5 of Ackerman Addition being the same as block 92 of the Original town, as shown by the foregoing plat, which is a correct delineation of said survey drawn to a scale of 250 feet to an inch. The Avenues are continuations of those of the same name in the original town. The Streets are continuations of those of the same number as adopted by the City of Havelock. Burr oak stakes are driven well into the ground at the front corners of each lot, and stones were found buried low in the ground as indicated. The width of Avenues Streets and alleys and dimensions of lots are indicated in feet and decimals by red figures on the plat. Each lot and block bears its own number.
