EASEMENT

THIS INDENTURE, made this 17th day of June, 1955 by and between

Joseph E. Fritz and Alvie J. Fritz, husband and wife, hereinafter called the first party and Edward A. Fritz, hereinafter called the second party, WITNESSETH:

1. That in consideration of the sum of \$1.00, in hand paid to the first party by the second party, the first party do hereby grant and convey to said Edward A. Fritz, second party, his heirs and assigns, the right and privilege of overflow of water over and upon the North Half of the Northeast Quarter of the Southwest Quarter (N $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty Nine (29) in Township Seven (7) North, Range Four (4) East of the 6th P.M. in Saline County, Nebraska in the slough or draw running north and south toward the eastwardly side of said premises located above a certain detention and flood control dam to be constructed by Edward A. Fritz upon the South Half of the Northeast Quarter of the Southwest Quarter (S $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty Nine (29) in Township Seven (7) North, Range Four (4), East of the 6th P.M. in Saline County, Nebraska, said dam to be constructed of such height that there will be a maximum of about six and one-half (6 $\frac{1}{2}$) feet of detention storage on the premises above described of the first party and to be further constructed so that said overflow water will regularly drain from the premises of the first party in a reasonable time through the outlets in said detention and flood control dam.
