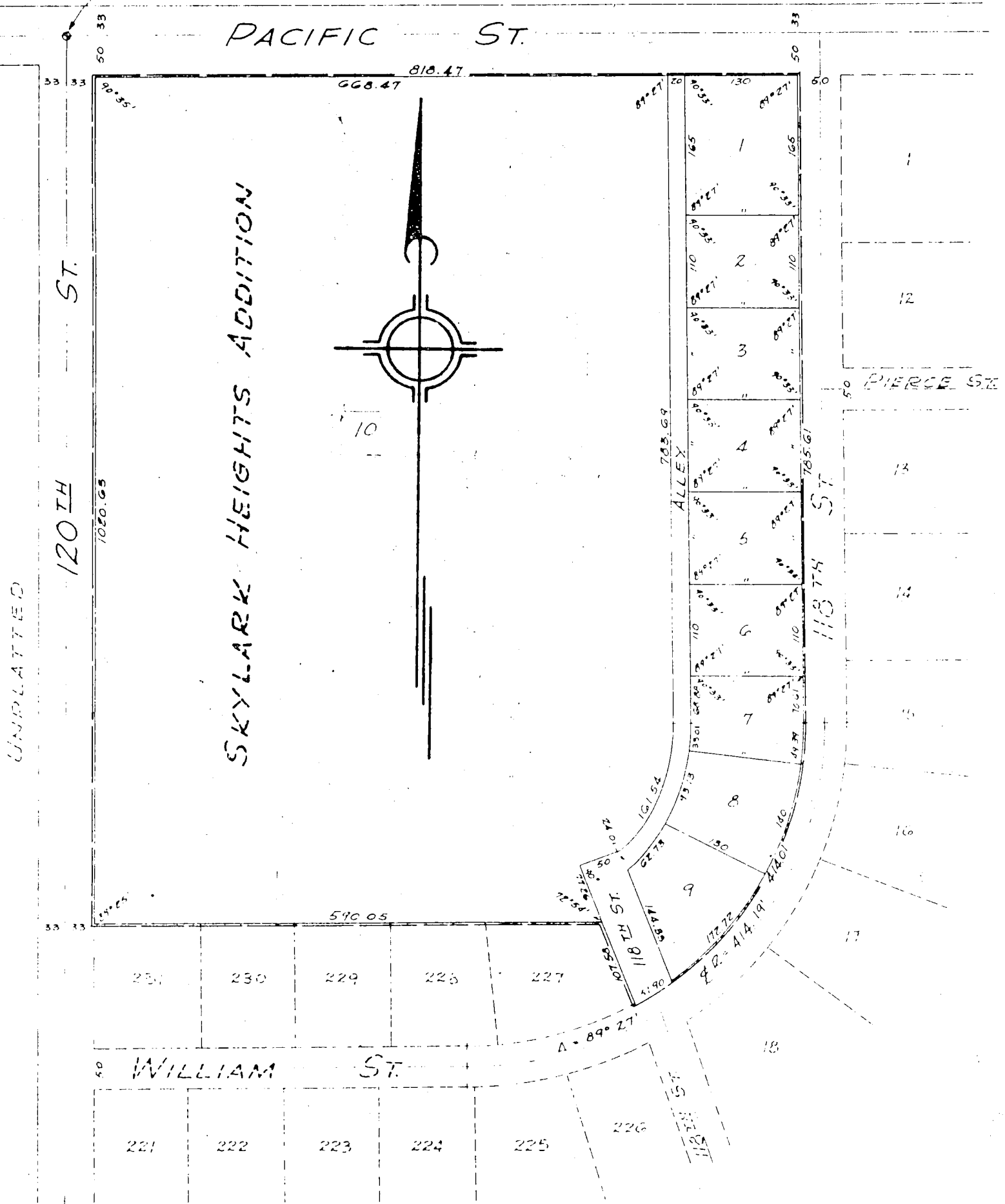


# PACIFIC PLAZA ADDITION

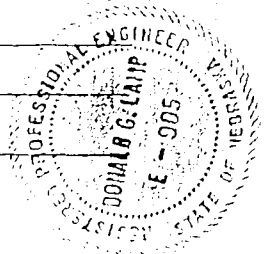
I hereby certify that I have accurately surveyed and staked with iron pipe all corners of all lots, streets, alleys, angle points and ends of curves in Pacific Plaza Addition and certify that said subdivision, Pacific Plaza Addition is a plat of portion of the Northwest 1/4 of Section 29, Township 15 North, Range 12 East of the 6th P.M. to wit:

Beginning at a point 33 feet East and 50 feet South of the Northwest corner of the NW 1/4 of said Section 29 thence East and parallel to the North line of the NW 1/4 of said Section 29 a distance of 818.47 feet thence South 0° 33' West 785.61 feet to the beginning of a curve to the right with a radius of 389.19 feet thence a distance of 414.01 feet along this curved line, thence North 17° 06' West a distance of 107.58 feet, thence due West 590.05 feet, thence North 0° 35' East along a line 33 feet East of and parallel to the West line of the Northwest 1/4 of said Section 29 a distance of 1020.63 feet to the point of beginning.

DEDICATION

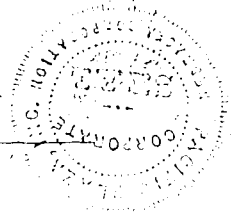
Known to all men by these presents:
