

SECOND: I give, bequeath and devise certain items of tangible personal property in accordance with a statement or list which I intend to leave at my death. If, for any reason, the statement or list is not in existence at my death or if in existence but fails to effectively dispose of all of such tangible personal property, I give, bequeath and devise such tangible personal property or that part thereof not effectively disposed of in accordance with the THIRD Paragraph of this, my LAST WILL AND TESTAMENT.

THIRD: All the rest, residue and remainder of my estate, of whatsoever kind and nature, wherever situated, whereof I may die seized or possessed, I give, bequeath and devise in the following manner, to-wit:

(A). One-third ($\frac{1}{3}$) thereof to my Daughter, Judy Svarc, to have and to hold as her property, absolutely and forever.

(B). One-third ($\frac{1}{3}$) thereof to my Son, Dale Svarc, to have and to hold as his property, absolutely and forever.

(C). One-ninth (1/9) thereof to my Granddaughter, Jennifer Meints, to have and to hold as her property, absolutely and forever.

(D). One-ninth (1/9) thereof to my Grandson, Matthew Frew, to have and to hold as his property, absolutely and forever.

(E). One-ninth (1/9) thereof to my Granddaughter, Hillary Frew, to have and to hold as her property, absolutely and forever.

FOURTH: In the event my Daughter, Judy Svarc should predecease me or in the event that we shall die simultaneously or in a common disaster, her share shall lapse and shall pass to each Jennifer Meints, Matthew Frew and Hillary Frew, Nicole Olson, Ryan Svarc and Jason Svarc, equally and share and share alike.




